3. Issues

3.1. ISS 0070 – Consequences of SPAA Change Proposal 0443

Richard Pomroy (RP) provided a brief update in relation to the data transfer mechanism for transferring customer details to the CDSP. He reported that the Workgroup view is to use the IX file for PSR information as this is secure and established. The next step is that RP will raise a change proposal for the February DSC Change Management Committee meeting to build a portal that will enable DNOs to send messages to Xoserve and for Xoserve to consider the most appropriate options for Shippers to provide data to Xoserve.

In addition, he clarified that this change will only apply to Suppliers who are SPAA parties. Adding that all Suppliers will be covered when the schedule migrates into the REC. The plan is that it will apply to all Supply Meter Points less than 1.4 gigawatt hours (GWh).

He reported that the next Workgroup meeting will be held on 26 February 2019.

Kate Mulvany (KM) also reiterated RPs comments saying that the Workgroup is cautiously optimistic whilst understanding the benefits there is concern about the use and management of personal data. She highlighted the importance of having a portal which is robust in terms of the data permissions.
