Re-categorisation of data in the Supply Point Enquiry API

1. Introduction and background

Following on from the successful implementation of the Supply Point Enquiry API, Shippers & Suppliers have requested that further data be added, along with some data to be re-categorised to community view in order to support a quicker and more reliable switching process. This should lead to more accurate quoting and subsequent billing for the end consumer and aid the Shipper/Supplier pricing processes which will also benefit the end consumer.

The proposed amendments to the Data Permission Matrix are therefore:

- a) Create a new version of the Supply Point Enquiry API that includes additional data items to be exposed to Shipper & Supplier entities
- b) Re-categorise a number of data items already available in portfolio view to Shippers/Suppliers and amend to community view
- c) Data items available via the Supply Point Quantities (Shipper only) to be added to the Supply Point Enquiry API (Shipper & Supplier) to allow the Quantities API to be decommissioned
- d) Add new data items to the DPM, for exposure with the Supply Point Enquiry API to Shipper/Suppliers

2. Data Items

Shippers already have access to data via DES & API both in a Community and Portfolio view for a range of data items. This DRR is proposing to:

a) Extend the number of data items contained within the Supply Point Enquiry API to Shipper and Suppler users, to facilitate this a number of data items need to be amended within the API Section of the DPM (see Appendix 1 for proposed DPM mark-up)

Below outlines the data items already allowed to be exposed to Shipper & Suppliers via API but is being requested to change from Portfolio to Community view:

4. Commercial model

The API service is already available within the Data Services Contract, Service Description Table, and Service Lines. This service is a Specific Service (Service Area 22) with charges set out in the Annual Charging Statement.

Within the Service Line, the "Corresponding obligation needed for delivery (Customer Responsibilities)" column will include words to the effect:

- Where the API call is made by a Proposing User, the Proposing User warrants that it has obtained the consumer's consent to access this data. The Proposing User also acknowledges that the CDSP may audit the Proposing Users use of the API Shipper Service.

5. Method of access to the dataset

Access to the dataset will be provided via an existing API (Supply Point Enquires). The API capability enables Xoserve to record each supply meter point accessed by each API user and to use this data to undertake audits where required to demonstrate consumer consent.

For the avoidance of doubt Xoserve will not provide access to the new data items (those in section 2) a to Shippers by any other means e.g. Telephone services etc.
