### 1. Introduction and background

Since the go-live of UK Link the CDSP have been using a cloud based data discovery and Business Intelligence (BI) technology to monitor and analyse internal data. The opportunity to leverage this CDSP capability provides customers with a new and more visual way to receive and interpret the data services we can provide. The data can be visualised in the form of charts, graphs and dashboards to easily identify key metrics, trends and outliers and then to drill down into the points of interest to focus on the key information. Drop 3 will provide additional information for Shippers to enhance the existing capability.

The proposed amendments to the Data Permission Matrix to facilitate Drop 3 are therefore:

a) Additional data items to be added to the Data Permissions Matrix to be provided in a portfolio view via the DDP to Shippers

#### 2. Data items

Shippers already have access to data via a number of delivery mechanisms both in a Community and Portfolio view for a range of data items. This DRR is proposing to:

#### 3. Privacy Impact Assessment

Where the disclosure of information includes the processing of personal data a Privacy Impact Assessment may be required.

Xoserve has considered the various tests that may be applied and considers that none of these are met and so a Privacy Impact Assessment is not required.

The tests (and answers) applied in determining whether a Privacy Impact Assessment was required were:

- a) Will the project involve the collection of new information about individuals?
  - No, this is existing data which is already available in Xoserve systems.
- b) Will the project compel individuals to provide information about them?
  - No, the data is already used part of existing processes.
- c) Will information about individuals be disclosed to organisations or people who have not previously had routine access to the information?
  - No, the data is already accessible to all via DES.
- d) Are you using information about individuals for a purpose it is not currently used for, or in a way it is not currently used?
  - No, data will be used for reporting and analysis by Shippers who have access to the data already it via a different mechanism.
- e) Does the project involve you using new technology that might be perceived as being privacy intrusive? For example, the use of biometrics or facial recognition.
  - No, the data is currently provided via other reporting mechanisms. This gives customers the ability to view the information in a different way and to drill down to meter point level in order to analyse or correct discrepancies
- f) Will the project result in you making decisions or acting against individuals in ways that can have a significant impact on them?
  - No, the project is looking to simply expose data additional for the third DDP Drop.
- g) Is the information about individuals of a kind particularly likely to raise privacy concerns or expectations? For example, health records, criminal records or other information that people would consider to be private.
  - No, there is no sensitive data about the customer or any individuals.
- h) Will the project require you to contact individuals in ways that they may find intrusive?

  No, there is no requirement to contact individuals in scope of the

  project
- i) Will the disclosure of information utilise new technology for Xoserve?
  - No, this is the third drop of data in the Data discovery platform.
- j) Will the disclosure include information that identifies a vulnerable customer?
  - No, the data associated in this request regarding vulnerable customers could not be used in isolation to identify an individual and is already available via DES.
- k) Will the disclosure release mass data to a party?
  - No, the data is already available in DES therefore can already be accessed by Shippers.
- Will the disclosure include information that identifies an occurrence of theft of gas?
  No, there is no request for theft of gas data.
- m) Will the disclosure require a fundamental change to Xoserve Business?
  - No, this does not impact Xoserve systems.

#### 4. Commercial model

There is no commercial model for Shipper access to Birst, as this will be provided in line with DSC Service Line 18 (Provision of user reports and information).

#### 5. Method of access to the dataset

Access to the dataset will be provided via Birst platform. All data and visualisations will be secure, ensuring that users can only see information that they / they organisation has the right to see. Access to the data can be provisioned through an interactive dashboard (with options to download relevant data securely) or simply emailed to users if preferred (PDF).

For the avoidance of doubt, Xoserve will not provide access to the new data items (those in section 2) available to Shippers by any other means than what is being proposed in this DRR e.g. Telephone services etc. unless explicitly stated.
