Section 1: Scope of EQR		

In order to select and onboard a supplier, £20K was requested and approved at August ChMC with the understanding that a further EQR providing Firm costs (by XRN) to proceed through to the end of Detailed Design phase should be presented for approval at the September ChMC.

Costing, by XRN, has now been completed. This EQR replaces the EQR approved at August ChMC.

The scope of the June 2021 release consists of 4 changes:

- 1. XRN4941 MOD0692 Auto updates to meter read frequency
- 2. XRN4992 MOD0687 Creation of new charge to recover last resort supply payments
- 3. XRN5093 MOD0711 Update of AUG Table to reflect new EUC bands
- XRN5142 New allowable values for DCC Service Flag in DXI File from DCC

XRNs 4941, 4992 and 5142 are awaiting governance decisions to be made on whether they are to proceed into implementation. Xoserve proposed that they are progressed through the Major Release process to the end of the Detailed Design Phase. A decision point has been scheduled for the November ChMC for the final decision to be made on whether to progress these changes into implementation (subject to MOD approval(s) / appeal decisions being made by 25<sup>th</sup> October 2020).

- Mobilisation of June 2021 Major Release team including supplier engagement
- Detailed analysis and detailed impact assessment of all XRNs
- High Level and Detailed Design of all changes
- Full project plan and full delivery costing
- BER production.
