### **Key Revenue Changes**

- The March 2021 MOD186 is consistent with the tariffs published SGN on 31 January.
- EXt includes final forecast for 2021/22 incorporating NTS RRC, impacting charges in 2023/24 on two year lag.
- The format of the current MOD186 report is designed to record GD1 revenues, as a result, March report reflects all GD2 revenues in Row Ref 5:9 and in 09/10 prices in line with GD1.
- The GD1 'lagged' items have been reported as usual in the individual lines.
- For GD1 lagged items RPI has been updated using the February 2021 HM Treasury forecast.
- Inflation from 18/19 prices for GD2 allowances is consistent with Ofgem's Final Determination.
