For the purposes of the UNC it is understood that the company name revisions can be achieved through a 'Consent to Modify', as it is not believed that such a revision is a material change to the intent of the UNC, and therefore does not require a change through the Modification process.

Nature of Modification

All references to "Transco plc" to read "National Grid Gas plc".

All references to "Transco" (including where Transco is part of another definition) to read "National Grid".

All references to "Transco NTS" to read "National Grid NTS".

Thus all the following definitions referenced in the <u>'UNC – Introduction, Transition</u> <u>Document, Modification Rules and General Terms – Defined Terms'</u>, and their use throughout UNC shall be amended as follows:
