Change Description:

Within the Connection and Disconnection Suite of jobs (this includes the CDN, CDR and CDJ (or CDJOB)) we do not attempt to define allowable values for the functional data items as the original regulations do not go to this level of detail. They do place an obligation on Transporters to record the information that is provided in a C&D Notification. It is for this reason that any notification that involves a connection and / or disconnection gets written to the C&D Store so that we are able to demonstrate this compliance regardless of the outcome of the transaction that writes to UK Link 'proper'. We cannot reject a CDN if the values don't match those that we'd expect, and it therefore follows that the CDR (and CDJOB) may include unexpected values. We try to convey this with the phrase 'anticipated values' so that Users are aware what we'd ideally like to receive (and in turn provide).

In the case that you quote you have highlighted that there is an error in the existing Code. The instance you quote was as a result of a JOB file being processed and the CDR is the confirmation that the details have been written to the C&D Store. In the instance that we are providing the value of 'U' in the CDR this is being incorrectly obtained from an alternative (and incorrect) source, but investigations suggest that this error has existed since the inception of this job in July 2004!

Reason for Change / Justification:

My understanding is that the majority of Users don't use the CDR (primarily I suspect that they haven't built the CDN) within their processing as it merely indicates that the Transporter has discharged the obligation to store the data. I suspect that this is why this error has lain undetected for as long as it has. Once we identify an error in the Code we would normally resolve this, but given the level of utilisation of this file, and the level of activity that we have at this point in time in the Legacy system to support Nexus Go Live, I have instructed the support team NOT to progress with any fix activities.
