

## Table of Unidentified Gas Weighting Factors for Gas Year 2023/24

Following the annual process described in UNC Section E and the steps set out in the “Framework for the Appointment of an Allocation of Unidentified Gas Expert” (UNC Related Document), including discussions at the UNC AUG Sub-Committee, the final AUG Table for Gas Year 2023/24 was presented at a meeting of UNC Committee on 26 April 2023.

The Table presented at the meeting complied with Urgent UNC Modification 0840 (Equalisation of prepayment and non-prepayment AUG factors) which was approved by Ofgem on 21 April and will become effective on 1 October 2023.

The result was that the final AUG Table was approved to take effect from **1 October 2023**.

The final Table of Weighting Factors is set out in the AUG Statement on page 4 of the document. For ease of reference the Table for Gas Year 2023/24 is reproduced here:
