

## Table of Unidentified Gas Weighting Factors for Gas Year 2024/25

Following the annual process described in UNC Section E and the steps set out in the “Framework for the Appointment of an Allocation of Unidentified Gas Expert” (UNC Related Document), including discussions at the UNC AUG Sub-Committee, the final AUG Statement and Table for Gas Year 2024/25 were presented at the UNC Committee meeting on 18 April 2024.

The result was that the final AUG Table was approved to take effect from **1 October 2024**.

The final Table of Weighting Factors is set out in the AUG Statement on page 5 of the document. For ease of reference the Table for Gas Year 2024/25 is reproduced here:

## Table of Unidentified Gas Weighting Factors for Gas Year 2024/25

These Factors are used in sharing out daily Unidentified Gas (UIG) as part of the Gas Nominations and Allocations processes, and also for sharing out subsequent UIG Reconciliation via the Amendment Invoice.
