## **1.0 Outline of Modification**

Tracey Saunders (TS) provided an introduction to the Proposal using the slides circulated with the agenda and advised that the Proposal essentially puts into code an arrangement that already exists in practice.

The solution will be to add into code a shipper obligation to pass on non-statutory payments in the same way as statutory payments are passed on and to add a specified timeframe (10 days) for shippers to pass on compensation payments they receive.

TS confirmed there is a separate SPAA Change Proposal to codify the non-statutory payment obligation for Suppliers. In addition, there will be an IGT change raised for this also.

## 2.0 Initial Discussion

Kirsty Dudley (KD) commented that this is the code solution but if compliance is not adhered to, she would like to know how it would be managed.

Bob Fletcher (BF) said that, the Transporters have an obligation to pay compensation and the Suppliers have an obligation is to pass it on to the end consumer and suggested that this could be sent straight to the Supplier.

It was confirmed that Demand Side Response payments will not be covered in this Proposal as these are NTS payments.

When asked out of all the payments made what % is a problem, Joanne Ferguson (JF) clarified that it is a significant enough problem for NGN to have identified it.

Kate Mulvaney (KM) agreed that a modification is appropriate but added it will be difficult to resource.

It was confirmed that the relevant Supplier is the Supplier at the time the payment is made.
