Minutes

1. Introductions

SC welcomed the group and introductions were carried out. SC went on to present the agenda items.

2. Actions from Previous Meetings

SC ran through all previous actions. (See updates above)

Action 143 – Shippers to send further examples of MPRNs that they believe to have been set to DE in error to Xoserve who will sort and pass onto the relevant Network.

3. Stats and Unregistered Reports

SC presented the industry statistics. (See Meeting Slides). SC also presented 2 new options for presenting the S&U Population Statistics.

The group agreed that “greying out” the Legitimately Unregistered and <12 Months Old pots and excluding those pots from the Population total was acceptable.

Action 144 – Xoserve to produce future statistics in the agreed format.

4. Shipperless and Unregistered “Pot” Priorities

At the request of the group in October’s meeting, Xoserve was asked to propose priorities for the several pots within the population in order to focus efforts to address the MPRNs contained therein.

MS presented priority 2 sets of ratings for each pot: Primary and Secondary priorities. (See Meeting Slides) The group concurred with the proposals.

5. S&U Sites DN Update

CW presented an update on behalf of all DNs on the work that the DNs are conducting to address the current population of S&U Sites. (See meeting slides)

6. Desktop Investigation / End User Letter Trial Proposal

Following the DN S&U Sites Update, MS presented a proposal on how Xoserve could conduct desktop investigation, end user lettering, and analysis on a sample of 1000 MPRNs. (See meeting slides) Further discussion between Xoserve and the Networks need to be conducted to finalise details and funding for the exercise.

Action145 – Xoserve to identify a sample of 1000 MPRNs from the Orphaned with Meters pot of the Shipperless and Unregistered in preparation for the start of the trial.

Action 146 – All shippers and Networks to compare the 1000 MPRNs to their respective portfolios to assist in data cleansing of the sample.

7. MPRN Creation Process Change Update

DM presented an update on the proposed changes to the MPRN Creation Process. (See Meeting Slides) A discussion followed regarding the merits and reasons for the change from the original proposal.

The discussion concluded with an understanding of why the proposal was changed.
