Shippers requested assurances that systems will be able to cope with the influx of files following the outage scheduled and other change-over aspects. Concerns were expressed on contingency and fallback arrangements to which xoserve agreed to respond. Project remains on track. In-house security (system penetration) testing completed on Ph 2. Thereafter, 3 rd party security testing to commence early 2008.
