# Governance

Kirsty Dudley (KD) asked what was meant by the term Consultation and asked that it is made clear exactly what the committee members are being asked to agree to and what they are voting for on each of the changes.

Rachel Hinsley (RH) explained that a Change Proposal can take one of three routes;

- 1. Acceptance to go to next stage (DSG)
- 2. Deferral route /consultation period (10 20 30 day) industry support change or not
- 3. Approve/reject then proceed to DSG for further development.

It is thought that the current Change packs that are issued may be causing confusion.

RHi then went on to explain there is a new process in development which would follow this:

- 1. Initial consultation to gain support for the Change Proposal
- 2. Solution consultation to gain views on solution options
- 3. Design consultation to gain views on the chosen design solution

All Change Proposals should always be presented to the DSC Change Management Committee prior to discussion at DSG; DSG meetings are twice monthly.

# 2.1. XRN4686 - Smart Metering Report

RHi confirmed this Change Proposal had been sponsored by CNG.

The proposal is to introduce a report to support the monitoring of Smart installations across the industry between I&C and Domestic SMPs. It is proposed this is considered at DSG to assess any further report requirements. There has been no consultation on this change to date.

This is a restricted class change to Shipper Users, therefore Shipper Users were asked to vote for the change to proceed. KD asked why this Change Proposal is being developed via DSC rather than SPAA. As this change relates to Smart Metering, KD suggested that it should be explored whether SPAA should develop it instead of DSC.

# 2.2. XRN4687 - PSR Updates for Large Domestic Sites

RHi confirmed this Change Proposal had been sponsored by E.ON.

The proposal is to introduce a solution to ensure that customers with an >73,200AQ are also included in the PSR as currently these are rejected and remain unknown on central systems. The CP has a number of solutions to be built up with DSG. There has been no consultation on this to date.

It was confirmed that the committee are being asked for this Change Proposal to go directly to DSG. There are 5 options for the solution in and the Committee agreed that DSG is the right place to discuss the way forward with this Change Proposal.

#### 2.3. XRN4690 - Actual Read Following Estimated Transfer Read Calculating AQ of 1

Emma Smith (ESm) confirmed this Change Proposal has been sponsored by npower.

The proposal is to assess solution options in relation to preventing understated AQs and AQs of 1 following AQ calculation. This occurs whereby a negative consumption is used in AQ calculation following a lower actual read following an estimated transfer read and could be impacting UIG. There has been no consultation on this to date.

This is a restricted class change to Shipper Users, therefore Shipper Users were asked to vote for the change to proceed.

ESm explained that this Change Proposal has been to DSG a number of times. There are currently four options for solution. KD asked if there is still any more refinement to do? ESm confirmed that DSG have considered all options. The Committee agreed to vote for the Solution Option Consultation to commence

RHi advised that this will be discussed further at the Governance meeting on Friday 15 June and said that some of the paperwork is not yet fully developed but is sufficient for members to be able to form a decision.

It was agreed that 10 days should be sufficient as there are only a few options available:

- 1. Do nothing;
- 2. Implement the same solution as XRN4510 (roll over the AQ)
- 3. Two further more complex options.

#### 2.4 XRN4691 - CSEPS IGT & GT File Formats (CGI Files) 1of4

It was confirmed this Change Proposal had been sponsored by WWU.

The following Change Proposals XRN4691; XRN4692 XRN4693 and XRN4694 all relate to file flows between DNs and iGTs.

These are restricted class changes to DNOs and iGTs.

Richard Pomroy (RP) presented the Change Proposals as a package of four and confirmed the committee will be asked to approve to send them out to Initial Consultation.

It was agreed that committee members would require 30 days for the initial consultation.

KD suggested from a governance point of view, the title of each of the CSEP Change Proposals are titled the same as that as on the agenda for this meeting. This suggestion was supported.

# 2.9 XRN4695 – Investigating Causes and Contributors to Levels and Volatility of Unidentified Gas

It was confirmed this Change Proposal had been sponsored by Xoserve.

The proposal is to request ChMC approve a new service line which initiates the CDSP setting up a team to investigate the causes of UIG and to provide recommendations to the industry. The service line impacts service area 3. There has been no consultation on this to date.

This is a restricted class change to Shipper Users.

Chris Shanley (CS) advised the committee that Urgent Modification 0658 includes the same change and a discussion was had around whether a Modification was required and whether or not the Modification would be withdrawn.

Linda Whitcroft (LW) recognised the issues with dual governance but advised that Xoserve would like to set up a team to investigate the causes and levels of volatility of Unidentified Gas and went on to explain that the request (in the EQR) for £40k is to understand the scope of work to be undertaken to reduce the causes of volatility. She explained that there is very broad costing for the service in the EQR.

Dave Turpin (DT) added for clarity that the initial analysis work needs doing to define the scope, allow a team to be setup. Completion of Modification 0658 is not required in order to do this.

It was explained that approval of the EQR will give ability for the BER to come back to this committee for further approval.

It was confirmed that the committee are approving the Change Proposal and EQR to enable the initial setup activities only (£40k funds).

CS confirmed that this is an important issue and felt it was appropriate that an amount of pre-spend is made ahead of the Ofgem decision on 0658 and approval of the BER. The BER will be bought to this meeting in July 2018 and Ofgem are expected to make their decision on the three UIG modifications, plus the urgent Modification 0658 on 6 July 2018.

#### 2.10 XRN4658 – Read validation – increasing outer tolerance value for specific AQ bands for Class 3 & 4 Meter Points

It was confirmed this Change Proposal had been sponsored by Gazprom.

CS clarified the Change Proposal is linked to a UNCC change which will be progressed next month and that the Change Proposal had consultation responses and understanding what the responses are would inform the decisions to be made.

UNCC is the governance group that deals with the industry rules and the DSC Change Management Committee is responsible for implementation and approval of the solution.

The proposal is to amend the current Market Breaker tolerance to allow a greater number of 'valid' meter reads to be accepted. This applies to the (Outer Tolerance Range (OTR)). The change is proposed for Class 3 and 4 meter reads only. The change proposal includes the current values and the proposed values alongside an alternative set of values.

RHi summarised the representations that have been received:

- 2 accept,
- 2 reject,
- 1 defer,
- 1 not published but it was also for acceptance.

There were no representations received from any of the DNs.

The key concerns are whether or not it is beneficial to the market and whether there is further analysis to be done. Most have asked for a couple of months lead time for implementation.

The funding of 37% (Shippers) / 67% (DNs) is based on the service line it impacts.

SM highlighted that analysis; took bulk of analysis had been undertaken to choose the tolerance levels that were most appropriate. Shippers were now asking to understand the analysis as they were concerned about the consequences.

James Rigby (JR) said that AQs can go from normal to abnormal very quickly/drastically and asked if the Distribution Workgroup can share the analysis that was submitted previously? Dave Adisson (DA) confirmed that this analysis is published and is transparent. He thinks there is warrant in this Change Proposal going back to DSG for further discussion which was supported by other members.

CS added that previous referrals to DSG have been positive and it is a good opportunity to share information/concerns.

SM said that he does not want any time wasted but reluctantly accepted the request for the Change Proposal to go to DSG.

SM advised the committee that the tolerances were set by using data submitted from Xoserve data; Gazprom and EDF.

DA provided clarity for SM by advising the scope for DSG to consider should be very clear and added that there may be multiple views but then a decision will be made on the best fit.

Xoserve would publish the analysis that supports the current tolerance proposal and encouraged the interested parties to view the data and provide analysis to support any concerns they may have.

The next steps for this Change Proposal were clarified:

Vote on Shipper only funding

Vote to refer to DSG and then DWG for awareness (including any views shared at DSG).

ESm confirmed that currently, delivery will be in November 2018 within Release 3 and asked the committee to confirm this is as expected. Xoserve are currently risk assessing if anything else is impacted within Release 3, if this is the case they will report back to the next DSC Change Committee meeting.

The proposal is to expand on the current MNumber service by providing a web portal service to end consumers. There has been no consultation on this to date.

This is a restricted class change to Shipper Users.

LW provided clarification on what is included in the service at the moment and what will be provided online.

LW confirmed the level of security in terms of who is eligible to access the web-based data and added that there is no way of proving who is the consumer via telephone.

#### 2.12 XRN4665 - Creation of new End User Categories

RHi confirmed this Change Proposal had been sponsored by E.ON on behalf of DESC.

The CP enacts the proposals within Modification 0644 to create new EUC profiles bands within 01 and 02 bands rather than splitting 01 / 02 EUC bands. The proposal is as per the below:

ESm confirmed there is no funding for iGTs on this Change Proposal.

It was made clear that this Change Proposal should be progressed on an accelerated timescale.

It was agreed that this Change Proposal will be put forward to DSG on Monday 18 June for a preferred solution to be decided on, then it will be sent out for consultation.

KD stressed that implementation should be as quick as possible.

A 10-day consultation period was agreed, which, if the consultation is issued on 18 June, would make 02 July the close out date.

RP said that this Change Proposal is a shipper issue and he does not believe DNs should fund it.

CS said that there could be implementation issues, the sooner this is out to consultation the faster progression to a point where it can be assessed whether it can be delivered by 1 October can be made.

# 3. Approval of Change documents

# 3.1 XRN4568 – DSC Service Description Table Cosmetic Changes to Service Line - CCR for Approval

ESm confirmed that the Change Completion Report (CCR) is being requested for approval to close the change which was a cosmetic change to the service line. All Constituency representatives are required to vote.

The implementation date was confirmed as 16 February 2018.

LCh presented the Future Release plan and highlighted it is now showing Internal and External Governance.

He then showed the high-level RAG status, in terms of delivery for the June 2019 release.

LCh confirmed this is a roadmap to say what is coming and what stage it is at, he also advised that is an extract from the Change Proposal register.

ES confirmed the master record is the Change Proposal register and that this is just a snapshot that comes to this meeting. KD asked for this to be put on the Governance agenda for Fridays meeting.

## 4.4 Central Switching Service (CSS) Update

Dave Turpin (DT) gave an update on the Central Switching Service (CSS).

The future plan shown on slide 3 of the presentation shows the Ofgem Timeline; Consequential changes and Costs and Deliverables for any BID to tender for being the CSS provider.
