#### 3. Issues

No new issues were raised.

### 4. Review of Outstanding Action(s)

**0701:** Wales & West Utilities (RP) to provide an update on the status of the SPAA Open Forum Change Proposal 0443.

**Update**: Richard Pomroy (RP) provided an update on the status of the SPAA Open Forum Change Proposal 0443, stating that the proposal was discussed on 22 August 2018 but he did not attend the meeting. CB reported that a joint SPAA, UNC and IGT UNC Workgroup was recommended to take forward the proposals and identify any further issues and alternative options. RP explained that there are 2 types of issues. One in relation to provision of information from Suppliers and the other in relation to the method by which data is provided to the CDSP and the Portal. He also expressed a view that in his opinion no changes to other Codes are required.

A brief discussion took place on the appropriate forum for this change to be discussed and whether this should be discussed and developed through DSC Change Management and the Design Specification Group (DSG) or the SPAA Working Group. RP suggested that the approach taken for the recent PSR changes should be followed.

Feedback form the SPAA expert group indicates that new file formats and data items would be needed to deliver the solution and it is not considered to be ideal to try and adapt existing arrangements.

Steve Mulinganie (SM) raised an issue in relation to the commercial implications in the context of fulfilment of Supplier obligations under the SPAA, particularly as not all parties are signatories to SPAA. RP stated that Suppliers and Shippers are expected to liaise to enable the Supplier to provide the information to the CDSP and Transporters.

Kate Mulvany (KM) signalled that the impact on Suppliers would be significant requiring a root and branch assessment of proposed systems and communication route to ensure confidence on ring-fencing the data and understanding the limitations and permissions. There is a huge risk of fines and reputational damage to Suppliers due to GDPR risks.

A brief discussion took place on the Portal in relation to data control and processes. Concern was raised about the potential use of extracted data. RP reassured Workgroup participants that contract level detail would not be shared and any communication via email or text would be of a generic nature and contain specific details.

Both SM and Lorna Lewin (LL) were concerned about Transporters liaising directly with Suppliers as this may pre-determine the outcomes and was not the desired contractual and licence route, consideration needs to be given concerning the differences between Electricity and Gas licensed parties.

It was suggested that the Distribution Workgroup considers this as a standing agenda item and a formal issue is raised on the UNC Issues Register. Action 0701 was therefore considered to be closed. **Closed** 

New Action 0801: Joint Office to raise a new issue on the UNC Issues Register in relation to SPAA Change Proposal 0443.

New Action 0802: Joint Office to contact SPAA to understand what is needed in relation to a Joint Workgroup.

### 5. Any Other Business

### 5.1. Modification 0666 (Urgent) - Establishment of a CSS Bid Group for CDSP central switching system bid activities

Chris Warner (CW) raised a question in relation to the planned meeting on 28 August 2018 in relation to the Modification 0666 (Urgent) - Establishment of a CSS Bid Group for CDSP central switching system bid activities. He queried why it was being held on that day and why it was a face to face meeting.

BF explained that the timetable for this Modification was set by Ofgem as it was agreed as Urgent. He confirmed that Joint Office would consider moving the meeting start time from 10:30 to 9:30 to allow industry parties to attend the UIG meeting due to held on the same day.
