179.3 Matters for the Committee's Attention

a) AUGE Procurement

FC briefly summarised the timetable required for the AUGE procurement process to ensure the process could be concluded prior to the end of the current agreement.

The following aspects were discussed:

- Stakeholder Evaluation Panel (SEP) representatives will not represent their own organisations, instead they will be individual representatives, as used in PAC.
- Some Members were concerned that individual liability insurance may be an issue.
- The SEP type model has been used before by the CDSP for the PAFA procurement.

- Members were unclear whether the SEP will make a recommendation to the CDSP and that the CDSP makes the final decision or whether the SEP decides.
- Existing DSC service line was clarified: DS-CS SA3 12 "Appointment of an organisation to the position of Allocation of Unidentified Gas Expert".
- Members explored an option to explore re-procurement via a Prior Information Notice without committing to re-procurement.
- Members agreed to vote solely on the question of the Prior Information Notice and to defer approval of re-procurement via an OJEU notice. This means the current AUGE will not be given notice at this stage.

• That the CDSP had approval to begin investigating AUGE re-procurement via Prior Information Notice, by unanimous vote.
