2. Update on confidentiality arrangements with AltHANCo

Richard Johnson (RJ) provided an overview of the 'AltHANCo – Four Items for Approval' document.

Following questions from SH and HC, Jayne McGlone (JG) indicated that the Confidentiality Agreement (CA), the Disclosure Request Report (DRR) and the Service Agreement (SA), all had to be in place before AltHANCo could receive the data they required.

A brief general discussion took place regarding the interrelationship between the three documents and it was agreed that the CA should be discussed outside the DSC Contract Management Committee. This topic was discussed by Xoserve and the GTs and IGTs, following this meeting.

3. ALtHANCo Request for an alternative reporting schedule

RJ explained that approval was required between Option 1 and Option 2 for the scheduling of the Disclosure Request Report.

Option 1: one report a month for six months, and then quarterly reports for the remaining 18 months – 12 reports (AltHANCo's preferred option)

The DSC Management Committee proposed that this was not in their remit to approve and that Xoserves could agree the timing of the provision of the report. Xoserve then confirmed that Option 1 was acceptable to them and this would be taken forward.

4. Monthly Contract Management Report (KPIs) Addition of Meter Location Notes to the Data Persmissions Matrix

RJ provided an overview of the addition of the Meter Location Notes to the Data Permissions Matrix and he explained this needed DSC Contract Management Committee approval.

All parties voted that the Meter Location Notes to the DPM should be approved.
