1. Introduction and Status Review

Bob Fletcher (BF) welcomed everyone to the meeting. James Abrahams explained that he has taken over the role previously undertaken by Eddie Blackburn.

1.1. Approval of Minutes (09 May 2019)

The minutes from the previous meeting were approved subject to a couple of minor typos in the attendee list – the initials for Mike Berrisford were showing as KJ and the word previous under agenda item 5.0 was incorrectly spelt.

2. **Review of Outstanding Actions**

Action 0401: Cadent (DD) agreed to circulate the actions from the last maintenance workshop held in August 2018.

Update: Darren Dunkley (DD) confirmed that the actions had been circulated but there were some outstanding actions from NGN and WWU. Workgroup agreed to close this action. Closed

Action 0404: Joint Office (BF) to include a recommendation in the Workgroup Report that the Offtake Committee to consider establishing a sub-committee to take forward the recommendations from this Review group.

Update: Agenda item 6.0 was deferred so this action was carried forward. Carried Forward

Action 0501: Reference the Issue Log Prioritisation spreadsheet – WWU (SC) and NGN (AP) to provide responses to DD by no later than 20 May 2019.

Update: DD highlighted that only WWU had provided a response. Workgroup agreed to close this action. Closed

Action 0502: Reference an OAD Related Documentation Review – Joint Office (BF) to look to provide a list of the various document (including their respective creation and publication dates) and to consider issuing these to knowledgeable parties in order to seek views on their continued appropriateness (i.e. should we continue to publish in one form or another) going forwards. **Update:** BF confirmed the list had been compiled and published. Participants agreed to consider the listing and whether these documents should be managed via the UNC. This action was therefore closed. **Closed**

Action 0503: Reference a CNI Workshop meeting - All Transporters to look to provide suitable contact details to Cadent (DD) in order that he may organise a CNI Workshop in due course. **Update**: Louise McGoldrick (LM) sought more clarification about the purpose of the workshop and what will be covered so that the right person could be identified to attend. It was suggested that a draft Terms of Reference would be helpful. Workgroup agreed to close this action.

It was noted that both this Request and the associated Modifications should be considering the impacts of CNI sites and how the OAD needs to be updated in terms of Site Owner and Site Users responsibilities for security on such sites. It was hoped the CNI workgroups would be able to highlight any other accountability changes or conflicts in the OAD. Carried Forward Closed

New Action 0601: Cadent (DD) to provide a one-page document setting out the aim and objectives of the CNI workshop and a broad outline of the discussion topics for the September meeting.

3. Consideration of Amended Modification

It was noted the Workgroup Reporting date had been extended to October 2019 Panel to allow time for the Phase 2 modification to be developed.

4. Prioritisation of Issue Log

Workgroup considered the proposed OAD review changes. DD indicated that the spreadsheet has been updated with responses and an overall summary provided to assess support for each of the individual changes. He also clarified that Cadent as proposer has not been included in the rating.

The scoring used to derive the summary position was as follows:

LM sought clarification of which of the issues are considered to be high priorities, in response DD indicated that Cadent are looking for all the issues to be addressed at some stage to help address some of the ambiguity in the UNC Code which can lead to mis-interpretation or inconsistent interpretation.
