2. New Change Proposals - Initial Review

2.1 XRN4627 CSS Consequential Central Switching Services

This new Change Proposal (CP) is the Parent CP for the CSSC Regulatory Change (Ofgem) and will be presented for information purposes only.

Ofgem launched the Switching Programme to encourage consumers to engage with the same energy market, and to improve their experience of doing so. Its aim to deliver reliable, next day switching for consumers by replacing the existing switching services with a new Centralised Switching Service (CSS).

As a consequence of the introduction of the Central Switching Service, Xoserve have had to undertake system and process changes to Xoserve systems. The CSSC Programme has been set up to ensure that all the changes required are designed, built and tested within the timelines specified by the Ofgem Switching Programme.

2.2 XRN5027 UK Link Data Cleanse of Conversion Factor in line with MOD0681S

This new Change Proposal is sponsored by E.ON

Modification 0681S introduces the CDSP being given the authority to update the Conversion Factor within the Supply Point Register in the following circumstances:

- a) where the AQ of a Supply Meter Point falls to 732,000 kWh or lower, the Conversion Factor should be updated to the default of the standard value of 1.02264, as specified in the Gas (Calculation of Thermal Energy) Regulations, with effect from the effective date of the new AQ
- b) where the AQ of a Supply Meter Point increases above 732,000 kWh, the Conversion Factor should be set to the last non-standard factor held on the Supply Point Register (if one is available) with effect from the effective date of the new AQ

In line with this modification which was based on recommendations from the UIG Taskforce, the CDSP will now conduct the required data cleanse activity on the Supply Point Register (UK Link) in accordance to rules a) and b) above.

During the development discussions of Modification 0681S it was recognised that around 15K+ Correction Factors required updating and it was envisaged this cleanse would occur in parallel with the developments of the enduring solution. The reason for this is the updating of the values which are known to be incorrect will result in benefits to UIG being realised as soon as possible.

Enduring developments for Modification 0681S will be completed via XRN4932.

The CDSP will only update values via rules a) and b) where the Shippers has not already updated values which have been flagged in the shipper packs.

The CDSP will only be updating Correction Factors which remain uncorrected at the time the data cleanse is conducted. The CDSP will issue a spreadsheet to Shippers Contract Managers (or an

alternative named contact) outlining which values have been updated and the values they went from or to.

Shipper Users will be expected to vote on whether this change should proceed to DSG and for Xoserve to initiate Capture.

Currently, the Change Proposal indicates the DSC Service Area 1: Manage Supply Point Registration, which is 100% Shipper funded.

2.3 XRN5029 Service Description Table updates October 2019

This new Change Proposal is sponsored by Xoserve

The Service Description Table has been updated to amend one service line and include two new service lines. Both the amended service line and two new service line are set out in Service Area 16 and impact on GT/iGTs only.

The amended service line (ASGT-NC SA16-06) relates to the process followed in the event of a call concerning a gas emergency.

The new service lines describe how Xoserve will enter into a Confidentiality Agreements as agent of GT/iGTs with a third party customer for services that are already approved under the DSC Third Party and Additional Services Policy.

Note: This change amends a service line and introduces new service lines that impact only on GT/iGTs. There is nothing to physically implement and no changes are being made to any systems as a result of this change. The Change Management Committee is requested to vary the Service Change Procedures, such that an Evaluation Quotation Report and Business Evaluations Report are not required for this Change Proposal. These documents would add no value to the Change Proposal and would be an inefficient overhead for the CDSP and Change Management Committee. This request is made as per Service Change Procedures para 4.1.3.

DNO and IGT Users will be expected to vote on whether this change should be approved

Currently, the Change Proposal indicates the DSC Service Area 16: Provision of supply point information services and other services required to be provided under condition of the GT Licence. No funding is required as this will be picked up as BAU
