BACKGROUND

- PAFA asked to attend UNC mod panel discussing implementation of urgent mods 0721, 0722, 0723 and 0724, to provide a view on the monitoring aspect of the mods.
 - Majority of industry responses contained a view that PAC would monitor these changes in some way
- Some assurance given by the Panel that UNCC and DSC would help to facilitate the requests of the PAC as soon as possible, to add reports to the PARR and speed implementation of reporting changes
- Mod proposer requested that PAFA prepare some change proposals to the UNCC for approval asap (next meeting 21/05)
- PAFA approached by Ofgem to discuss performance assurance of the proposals

ADDITIONAL INFORMATION

- UNC Panel very interested in facilitating changes to the PARR
 - All reports to be added to the PARR and data items to the DPM to ensure that PAC have access to all data required and in un-anonymised format
- Potential for these to be 'B' reports to aid speed of implementation, for during lockdown with 'A' reports developed for post lockdown, as more likely to be targeting at this point
- PAFA can receive and manage the processing of reports via the FTP if DDP implementation is not feasible giving the time constraints
- To aid speed of delivery PAFA propose that MPR level data is requested as a DPM data item and specified in the PARR but made available on request (within appropriate timeframes) should industry behaviour indicate further examination is necessary.
