Ex-Committee action via Email (forwarded by PAFA to Xoserve): "Also perhaps you could present to PAC proposals for Xoserve to confirm the status of all by-pass valves perhaps a photo-audit (could a photograph confirm whether a by-pass is open or not?)."	There are c. 150 open Meter bypasses according to UKLink. 150 site visits would be required to photograph all of these installations – would it require relatively skilled resource to understand what they were looking for – and to interpret the results (photographs)? This could be requested from a) Shippers, who would need to engage with Suppliers and customers to gain access b) DNs, who would require funding for the work, as it is not covered by their current cost basis c) specialist 3 rd party meter reader – would not have any rights of access if the customer refused. Would they have the specialist skills to recognise a bypass? If paid by Xoserve would need to be funded via a Change Proposal. There are over 12,000 Meter bypasses in the country according to UKLink. PAC would need to prioritise any compliance work relating to bypasses against other ongoing work – and factor in the likely impacts of COVID-19 and further national/regional lockdowns. As the number of sites with no recent meter reads is creeping up, is that a higher or lower priority than meter bypasses?
