ripeulie	 The Change Pipeline includes a delivery plan for all live Change Proposals. This has been broken down into January 2023 – May 2023, June 2023 – February 2024, Change backlog and DSC Change Pack Plan. REC Change Update – Pipeline view of REC change provided Following provision by GRDA of Preliminary and Detailed Impact Assessments to the REC we understand that there has been a change of design by Landmark. This design is materially different from the design communicated to us previously and will require new Impact Assessments to be conducted by the GRDA. We have submitted a series of design assumptions to the Switching Operator for us to complete a [Preliminary] Impact Assessment, until these are clarified we are unable to complete this. It's highly likely that we will need to amend the funding which has already been approved by ChMC for XRN5567. We will endeavour to bring a revised BER to the soonest possible ChMC meeting but this may be provided at short notice, and may require approval ex-Committee should we establish that this will be critical to keep the implementation in December 2023 viable.
