Incident CSS P1 Missing Secure Active Messages Update

PRB0040672 / XCE2006: Missing Secured Active Messages:

An update was provided on latest ongoing P1 DCC switching incident which has impacted and prevented 57k gas registrations going live to date, with a potential to impact a further 30-50k future dated Registrations. DCC are yet to understand the magnitude of the incident and define a resolution plan. Customers recognised the efforts and support provided by Xoserve on this matter.
