2 – Budget Movement & Change Pipeline	BP23 General Change – Total committed spend has increased by £119k since last reported. The August Change Budget spreadsheet was shared to show the updates and how the budget and spend is now split between General Change Budget, REC Change Development and PAC.		
	Change Budget BP24 – Proposal is to retain the same size General Change budget from BP23 into BP24, based on Major Release bandwidth, historic trends/costs, unknown but expected REC Change Development demand. In addition, Xoserve reiterated the that the proposal for BP24 is to include Data Discovery Platform (DDP) work into the BP24 General Change Investment - with a view of being able to replicate the controls and governance afforded to all other DSC Changes.		
	• The Change Pipeline - Includes a delivery plan for all live Change Proposals. This has been broken down into January 2023 – May 2023, June 2023 – February 2024, Change backlog and DSC Change Pack Plan. All updates from the previous month have been highlighted in orange in the slides.		
3 – Change	 REC Change Update – Pipeline view of REC change provided. As a result of industry activities, we were required to raise 2 urgent Changes. XRN 5675, was raised following the DCC P1 incident to create a meter reading for the CSS reflective date in UK Link that will be used for settlement reconciliation. This will cause a delay to both IAs for R0071 and R0110, however customers were supportive of the Change and agreed spending can begin. XRN 5668, has been raised to allow us to take a data cut to align with the MHHS program. Again, customers were supportive of the Change and agreed that spending can start and implemented on 19th August 23 New Change Proposals
