1. DSC Committees - Introduction

- Each meeting of a DSC Committee shall be chaired by the Code Administrator ("Committee Chairperson")
- Certain Modification Rules (Panel meetings) apply; Alternates, notice periods, form of meetings, observers, minutes
- A DSC Committee may establish a sub-committee and can decide on its members and terms
- A DSC Committee may decide to refer a matter to the other DSC Committee
- DSC Committee shall be quorate if they can exercise seven (7) votes or all Committee Representatives of the relevant Customer Group are present
- UK Link Committee business will transfer to the Change Management Committee.

Committee Representatives

- Committee Representatives for Change Management and Contract Management Committees will be in place for 01 April 2017
 - Appointed initially for 18 months but thereafter membership will be for 12 months
 - IGT representatives can attend DSC committees prior to Nexus implementation
- Decisions can be made by the vote of the:
 - all Committee Representatives (a "Full Vote"); or
 - Committee Representatives of a particular Customer Group.
 - Consensus is the aim, simple majority is the method.

3.Date Options: Some Core Assumptions

- Change and Contract meetings should:
 - Not be on consecutive days
 - Be kept in sequence: change then contract, and
 - Be no more than 1 week apart.
- More likely that information will flow
 From UNC workgroups to DSC change committee and vice versa
- Note: UNC Panel Dates (third Thursday)
 20 April, 18 May, 15 June, 20 July

Date Options – aiming for consensus

 Many date options and combinations have been considered (see appendix 1).

 Option A appears the most likely to work, taking into consideration the assumptions and the industry meeting dates known.

- First meeting: Wednesday the week before UNC Panel (as is the case currently) 12 April 2017
- Second meeting to be scheduled for the next day (may be cancelled if insufficient business) – 13 April 2017 (uses UKLC old date)

Contract Management Committee

 Meeting date is currently the day before Panel but proposed that it is moved to the Tuesday* after the Change Management Committee – 18 April 2017 (2 days before Panel)

Credit Committee

 Meet on the same day as EBCC (consecutively), 4th Monday of the month - 24 April 2017

Post-Meeting Addenda (1 of 3)

• Post-meeting addendum: Statement from the Joint Office regarding meeting dates.

"We strongly advise that the Contract Management committee is not held on the day before the UNC Panel for 2 key reasons:

- 1. It clashes with the iGT UNC Panel day and this has a direct impact on membership, and on wider industry involvement with simultaneous important meetings.
- 2. The UNC Modification Panel and UNC Committee meetings take precedent as they provide the overarching governance for the UNC. The JO has significant administrative tasks to prepare for the meetings on the day before, on the day of the meetings themselves and often (subject to the amount of documentation involved) on the day after.

The Joint Office has a small team and these new DSC committees provide additional responsibilities without corresponding resourcing changes (recent JO recruitment is to underpin core UNC activity - which was already a shipper concern). It is inevitable that the JO is the pinch point in the arrangements as we have to meet all needs, and not just one specific meeting. It should also be borne in mind that this assumes that there are no absences in the JO team - realistically there is always at least one person on leave - and it would only take a further absence for any reason to place undue strain on the JO. The workload can be accommodated providing it fits within the wider obligations put on the JO, and we ask that members recognise the need to balance all priorities. We believe we have presented reasoned options that seek to achieve a compromise in the interests of all parties.

However, if this is the only date that is acceptable to industry, we will try our best to meet the expectation. Members will need to note that meeting minutes and associated administration will probably not be available until the following week because of the need to support Panel day".
