N/A UK Link Tech Refresh

Committee discussed the xoserve presentation as provided, culminating in xoserve confirming the contingency arrangements covering delayed nomination files and consequential rejections.

13861 Rejections associated with Shipper AQ Amendments

Committee discussed the adoption of a 'notional' implementation date of 23/02/08, whilst the actual implementation date will be prior to this. 1st issue of the associated rejection notices is expected to be around the AQ window in May 08. As the system changes have not yet been applied, this change will drop back into the revised May implementation timeline. Remains on the plan for visibility purposes only.

13829 DN Interruption Reform

Remains on schedule for a 29/03/08 implementation. The Committee discussed the approval of the two file format changes, culminating in giving their approval.

Remains on schedule for a 01/04/08 implementation. The Committee discussed how best to progress this change in light of the fact that UNC modification 0188/0188A has yet to be approved by the Authority. Shippers requested assurances that systems will be able to cope with the influx of files following the outage scheduled and other change-over aspects. Concerns were expressed on contingency and fallback arrangements to which xoserve agreed to respond. Project remains on track. In-house security (system penetration) testing completed on Ph 2. Thereafter, 3rd party security testing to commence early 2008. Detailed contingency arrangements discussed in the 'open forum' meeting. Specific discussions on contingency arrangements for delayed nomination files and consequential rejections undertaken along with identification of PRN file requirements.
