TD invited the Workstream to consider the merits of an informal review of how the Modification Rules were operating following the approval of Modification Proposals 0078 and 0084. The Workstream concluded that a few months further experience should be gained before considering any Proposal of the type suggested within Action 1018. This action was therefore closed.

MY suggested a review of the Urgent modification process would be desirable. Recent experience indicated, in his view, the need for more structure. Should there, for example be a minimum period for Panel consideration? TD pointed out that that, on exceptional occasions, a very short consultation period may be required. He also pointed out that whilst the Modification Rules on Urgent Procedures were very flexible, aspects of standard practice had developed, including the provision for five Business Days consultation and five further Business Days for Modification Panel members to review the report. RH pointed out that the rules permit Ofgem to consider the appropriate time-scales prior to agreeing the procedures with the Transporters.

It was agreed that a new Topic on this subject be raised. MY offered to prepare some thoughts for the February meeting.
