3.1 011GOV Urgent Proposals

BGT's document "Guidance Note on Best Practice for Urgent Uniform Network Code Modification Proposals" was discussed. One comment had been received - that the JO should publish all Proposals as soon as they are received whether Urgent or not. This would give extra time for respondents to view the Proposal but may also be seen as giving an opportunity to "lobby" Ofgem.

DE stated that Ofgem had, recently, turned round the Proposals quickly and was concerned that parties lobbying Ofgem might delay the decision. He also suggested that if the period of consultation is reduced, the Panel may be more likely to decide to review the area concerned after Ofgem's decision on implementation. However, it was acknowledged that recent Urgent Proposals had been discussed in draft form but this had not led to delays.

RH stated that a Proposer might wish a Proposal to remain confidential if Urgency was rejected. JM, however, pointed out that the Proposal would still need to be published on the website so would not be confidential. It was also pointed out that

any Proposer might wish to discuss any Proposal beforehand with Ofgem informally if it wished to retain confidentiality.

CWa had a few comments which he read out and agreed should be forwarded to CWr. These centred on acknowledgement that a Panel recommendation was a licence condition and he wished to ensure that the guidelines did not appear to contradict this.

Action GOV1025: BGT to consider further comments and if necessary redraft the Urgent Procedures Guidance Note for the June Workstream meeting.

3.2 012GOV Legal Text Aspects of Current Rules

SGN were still engaged in preparing changes to the Modification Rules.

4.0 Any Other Business

CWa referred to the fact that the IGT UNC Panel had been convened. It was concluded that it was not appropriate for the UNC Panel to receive a report from the IGT UNC Panel. It was also concluded that the Modification Reports did not need to refer specifically to impacts on the IGT code.
