LS stated that she wished to proceed with discussion of this Topic when time and resources permitted. It was agreed that this Topic remain on hold.

4.0 Any Other Business

Members discussed how best to interpret 'immaterial' with regard to UNC Modification Proposal Variation Requests. Consensus was reached that a reasonable test was that change could be regarded as material if making that change might be expected to alter representations made.

GE advised members that at the recent Shipper meeting, Ofgem had voiced concerns regarding named Ofgem individuals being highlighted within Workstream and other meeting minutes. It believed that this may compromise their 'no fettered discretion' stance. TD pointed out that it is widely acknowledged that the current approach does not 'commit' Ofgem to any decisions, and merely acts as a welcome and helpful indication. Members reaffirmed their belief that accurate minutes are an integral part of the process, whilst commenting that Ofgem's continued participation in industry meetings is invaluable in assisting them (and others) to make informed and timely decisions. DE advised members that Ofgem were scheduled to conduct an internal meeting to discuss these matters.
