CWr asked about Ofgem carrying out a Review of Governance. JD confirmed that Ofgem is considering conducting a review across all codes and identified some of the current issues. He expected that Ofgem would initiate this in early 2008. PB suggested that the Workstream raise this as a Topic when the review commences.

RH asked about reflecting approved Modification Proposals with future implementation dates in the Uniform Network Code. He believed that previously such text was included in the main body of the Code from the approval date, but the existing text was placed in the Transition Document to apply until the implementation date was reached. The Workstream agreed to discuss this at a future meeting.

JD repeated Ofgem's preference for receiving a commentary with legal text so that it is clear, for example, which proposed changes to the text were associated with which aspects of the Proposal. The Transporters agreed to reflect on the request and respond at the next Workstream. CW suggested that if a Proposal is clear, this type of commentary should not be necessary and suggested that problems experience are characteristic of a lack of clarity.
