1. Confirmation of membership and apologies for absence

The meeting was declared quorate.

2. Review of Minutes and Actions from the previous meeting

2.1. Minutes

The minutes from the previous meeting were approved.

2.2. Actions

DE0401: Shippers to trial Options A and $\underline{C} \in \mathbb{E}$ and produce and present analysis and results.

Update: Ongoing. Carried Forward.

DE0402: Xoserve to publish the Demand Estimation sample data from last year used for gas year 2011/12.

Update: MP confirmed that Xoserve have published the sample data from last year and will publish another 12 months of data next week. **Complete.**

DE0403: a) Xoserve to update the Weather Station Substitution Methodology Technical Requirements document; and b) JO to publish for review/comment (within 7 days) and invite member approval by email.

Update: FC confirmed that this has been finalised and will be used for the tender process. **Complete.**

DE0404: Contact Chris Warner (National Grid Distribution)DESC members to establish appropriate contacts and provide a view on the procurement of non-Transporter data for samples as permitted under Modification 0258A.

Update: FC confirmed that National Grid had received limited support when raised at the Distribution Workgroup as it was considered that the Meter Asset Managers would need to be approached. FC explained that the UNC allows for the collation of

data however it would still need to go through the same validation processes. The practicalities of this approach were considered. FC explained that the current sample is established from a random sample of customers, who are approached to participate in the collection of data, however the code modification is for sites that already have AMR and could provide the data for sampling. MR suggested that each Shipper member of DESC establish within their own organisation who would be the most appropriate contact. It was agreed to amend this action for DESC Shippers/Suppliers to establish a view. It was considered if previous sites that have been lost from the data sample could be first approached if AMR equipment was still present, or where Smart Meters have been installed if the supplier would be prepared to provide the data. **Carried Forward.**

DE0405: Use of non-Transporter data samples (Modification 0258A) - Provide details of Electricity Modification P223 for review and discussion.

Update: MR confirmed that the document would be provided to Xoserve. Closed

Weather Station Substitution Methodology Technical Requirements

Xoserve provided the Draft Weather Substitution Methodology. The clause relating to replication of the methodology had been revised with Shippers' input before the meeting, and it was agreed that the Technical Requirements were now fit for purpose and could be used as the basis for procurement of a service.
