## <u>Proposal to the Offtake Committee for</u> <u>Changes to the Offtake Communications Document dated 27<sup>th</sup> April 2005.</u>

## Background

The purpose of the Offtake Communications Document "OCD" is to set out relevant details regarding the required flows of information between Transporters such that they can meet their respective obligations under the UNC. It is a Subsidiary Document as defined in OAD Section N 1.2. Hence it is for the Offtake Committee to keep under review and to decide whether any modification should be put forward and/or implemented.

UNC modification proposal 0045 "Provision of Available Interruption Information" was implemented with effect from 06:00 hours on 11/11/2005. This modification requires DNOs to provide to National Grid NTS a statement of the aggregate daily gas flows at Interruptible LDZ Supply Points. This new inter-Transporter communication should be captured within the OCD to record specific details relating to the information required.

Whilst reviewing the section of the OCD relevant to modification 0045 a number of errors in the existing text have been identified.

## Proposal

It is proposed that the OCD be amended as provided in the attached table. Specifically:

- 1) A new record should be added in respect of clause I 5.1.4 to align to modification 0045.
- 2) The reference to clause I 5.1.3(a) should be amended by deletion of "(i)" such that the record also captures sub-clauses (ii) and (iii).
- 3) The record relating to clause I 5.2.4 should be amended to transpose the sender and recipient parties.
- 4) The records relating to clauses I 5.2.1 to I 5.2.4 should be amended to show the means of communication as "fax" which is the current method rather than "SC95".
- 5) It is further proposed that all references within the OCD to Transco NTS are replaced with National Grid NTS (not identified in attached table).
