UK Link Modifications Implemented

- 13785 'UK Link Manual Update – UPN Format Update to v2'
This was implemented, with minor corrections agreed, on 02/10/06.
- 13783 'UK Link Manual Update – S59 – Correction to File Formats'
This was implemented, with minor corrections agreed, on 02/10/06.

Approved UK Link Modification

- 13780 'IFA Invoices via IX'
Correction to a minor file formatting error was agreed. Implementation date of 03/11/06 unchanged.

Topics Discussed

- 004UKL 'UK Link Testing Arrangements'
Scottish Power has indicated that it is still considering whether to proceed with this potential Class 3 UK Link Modification and expect to report back to the November meeting.
- 006UKL 'Gemini Performance Monitoring' xoserve advised that following approval, work has commenced, with a proposed implementation date of 15 December 2006. First batch of reports expected January 2007 with a full month's data available from February 2007.
- 007UKL 'Release governance procedures'
Initial SMS trial conducted and Users 'take up' responses sought to establish cost effectiveness. Confirmation of the service provision to be communicated to the UK Link Committee after 20 October 2006 and thereafter, implementation proposed for November 2006.
