# **Smart Energy Code (SEC) Update**

# 1. Purpose

This paper intends to inform the Uniform Network Code (UNC) Modification Panel and UNC Parties of the activities occurring in relation to the SEC.

# 2. Spotlight on the SEC Seminar - Sheffield

The next Spotlight on the SEC seminar will be held on 18<sup>th</sup> May 2017 in Sheffield. This is the first SECAS event to be held outside of London, in response to SEC Parties seeking opportunity to engage directly in these events.

The Spotlight on the SEC is a quarterly seminar hosted by SECAS, and will have representatives from DCC presenting as well. Topics will include general updates on the Code, and presentations on becoming a DCC User as well as a focus on fulfilling the Security and Privacy requirements on the SEC.

### 3. SEC Modifications Update

#### 3.1 New Modification Proposal

Since the April 2017 UNC Modification Panel meeting, one new Modification Proposal has been raised. This is outlined in Table one below.

SEC Modification Proposal	Summary of Modification
SECMP0035 – Updates to SEC Appendix B – Organisation ARL expiration date to be aligned to DCCKI ARL	This modification looks to ensure that the Smart Metering Key Infrastructure (SMKI) Organisation Authority Revocation List (ARL) is aligned to the Data Communications Company Key Infrastructure (DCCKI) ARL; amending the expiration date of the Organisation ARL from 12 months to 13 months, as per the DCCKI Certificate Policy (CP) and the DCCKI ARL.

Table one: New Modification Proposals

The SECMP0035 Initial Modification Reports (IMRs) will be considered by the Panel at the May 2017 meeting.

#### 3.2 Approvals and Rejections

The Change Board at its 19th April 2017 meeting voted on five Modification Proposals.





#### Path 2 – Authority Determination:

- SECMP0004: Inclusion of Device Serial Number data item in the Smart Metering Inventory – Change Board recommendation to the Authority was for the approval of SECMP0004;
- SECMP0008: Provision of a DCC Alert (formerly Service Request Error Response) for Quarantined Service Requests – Change Board recommendation to the Authority was for the approval of SECMP0008; and
- **SECMP0011: Including the MAP ID in the Smart Metering Inventory –** Change Board recommendation to the Authority was for the rejection of SECMP0011.

The outcome of these Change Board votes has been captured in the updated Final Modification Reports that were issued to the Authority (BEIS per the transitional arrangements) on 21<sup>st</sup> April 2017. The Modification Proposals now sit with the Authority for determination.

#### Path 3 - Self Governance:

- SECMP0021: Increase the representation of the "Other SEC Party" category on the SSC and TABASC majority decision to reject by the Change Board.
- **SECMP0033: Update to CH Handover Support Materials** unanimous decision to approve by the Change Board.

SECMP0033 will be implemented on 11th May 2017 with the designation of SEC5.7.

#### 3.3 Referred Change Board decision to the Panel

Following the majority Change Board recommendation to reject SECMP0021, a SEC Party, who is also the Proposer and a Change Board Member has referred the decision to the Panel for determination.
