Market Trials Accelerated Governance Process 8 October 2015

The Issue

- Market Trials Level 2 commences 2 November 2015.
- Market Trials Testing will take place between Xoserve and Market participants.
- This may lead to a number of issues which may necessitate a change to the approved, baselined file formats and heirarchies.
- These changes require progressing in an expedient manner so that re-test can take place.
- Current UKLC approval timelines are too slow to deal with this.



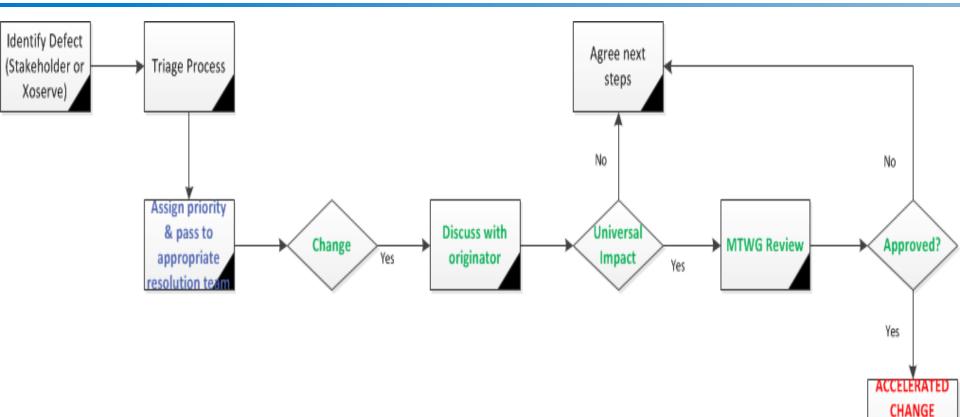
Accelerated Fortnightly Proposal

- Aims to facilitate proposed changes to be progressed through the approval process in an expedient manner.
- Meeting will be T-con.
- Will be cancelled if no changes required.
- Will commence to coincide with start of MT2.
 - Runs to end MT3/4 or beyond?
- UKLC administered by Joint Office.
- Allows any change to be approved expediently and development to commence by all stakeholders.
- Approved changes will be dropped into MT programme as per the Release Schedule.
 - These dates have yet to be defined
- The 'Accelerated' process covers a 19 day cycle from issue of FF changes to approval or rejection.
- Shipper Rep period reduced from 10 to 5 days
- 5 day response period for Xoserve.
- Discussion of proposed FFs in UKLC prior to approval meeting.
- Monthly UKLC will continue for BAU (Reporting & Non Nexus approvals)

Market Trials Considerations

- Defect classified as
 - Fault e.g. An organisation has incorrectly built the file. (UKLC not req'd.)
 - Change e.g. Process doesn't work. New Process or revised FFs req'd.
- Changes will be global changes and not organisation specific.
- Need to limit the number of changes in each Change Pack to 20.
 - Due to resourcing and timescale issues.
 - Potential to prioritise critical MT files.
- Meeting will deal exclusively with global 'Must Have' changes only.
- Changes will have been agreed through MTWG in the up-front process.
 - UKLC should be able to minimise debate because of this.
- Release timetable not yet defined.
 - N.B. MT L2 approach walkthrough is scheduled for 8 Oct where this will be addressed.



- Any changes identified via UAT will fall into this process.
- Shippers get early visibility of the Changes.
- Expedient approval gives stakeholders more certainty, which enables them to develop and build solutions.
- What is the escalation process in the event of a dispute?
 - Currently UNCC. Sits monthly do we need an alternative?
- Not all concerned shippers attend UKLC. (Constituency voting)
 - Do we need to widen the scope of attendees?
- Normal monthly UKLC will be utilised for non-Nexus business.
- First review T-con will be 16 November.
- First approval and review T-con will be 30 November.
- Changes will be global changes and not organisation specific.
