Today's Objective

- Fulfil the Committee's UNC obligation
 - E9.4.3 In respect of each AUG Year:
 (e) the Committee approve and publish the AUG Statement;
- AUG Framework requirements:
 - The Committee shall approve the Draft AUG Statement (including revisions), in the form presented by the AUG Expert, unless they unanimously agree changes to any part of the document. Any changes directed by The Committee in this fashion will be implemented by the AUG Expert immediately. The approved Draft AUG Statement will be treated as the final AUG Statement. (Para 7.1.8)



Options for today's meeting

- Unanimously agree changes to Revised Draft AUGS published 28 April
 - Does any party propose any changes?
- Otherwise the AUGS is approved

Background

- Modification 0473 Project Nexus Allocation of Unidentified Gas – approved by Ofgem in April 2015
- Re-introduces concept of an Allocation of Unidentified Gas (AUG) Expert in a post-Nexus world
- New AUG Expert defines a Methodology to determine weighting factors to be used for distribution of daily UG rather than a total UG quantity
- DNV GL appointed as AUGE in July 2016




Implementation of Mod 0473

- Implementation Date aligned to Project Nexus Implementation Date (PNID)
- AUG Year commences 01 October each year
- An Interim Table of Weighting Factors will apply from PNID until start of next AUG Year
 - Currently included in new AUG Framework Related Document
 - To be incorporated in UNC TD under Mod 0609
- AUGE has two key deliverables:
 - AUG Statement (Methodology) revised version published 28 April
 - http://www.gasgovernance.co.uk/augenex/1718
 - AUG Table of Weighting Factors final Table due for publication by 1 July

Update on 2017/18 Process

- AUG Framework process has been followed to date:
 - Draft AUGS 01 February
 - Additional Walkthrough meeting during feedback window
 - 3 parties made comments on Draft AUGS
 - Response meeting for AUGE to respond to comments
 - Revised Draft AUGS 28 April
 - Revised AUGS Walkthrough meeting 12 May
 - Revised AUGS now tabled for UNC Review
