1. Outline of Modification

1.1. Introduction to Modification presentation

JW provided an overview of the presentation, during which RH made reference to the Xoserve 'WAR Band Analysis' presentation provided at the 05 March 2018 Performance Assurance Committee (PAC) meeting. when asked whether the 25% of relevant sites on default WAR band were evenly distributed.¹

When considering the 'Solution' slide, SM enquired about EUC Bands 1 and 2. JW explained that there is no winter annual ratios involved in Bands 1 and 2, and therefore they are not seen as an issue.

Moving on to consider the 'UNC panel points' slide, JW advised that after discussing the matter in more detail with Naomi Anderson following the 15 March 2018 Panel meeting, he is happy to consider removing the references to the PAC settlement register, the values involved and the model utilised to create the figures.²

When asked how many Shippers were causing concern's, RH pointed out that the information is available within the 'WAR Band Analysis' presentation. RH confirmed that the 'target' is zero percentage. Having considered the PAC presentation, GE commented that he remained uncertain about which parties are actually contributing to the problems. Further, he confirmed that he does not believe that the issue as highlighted, is widespread within the industry. Responding, DA pointed out, the need to maintain confidential arrangements. Whilst noting GE's concerns, it was felt that this matter should be considered in more detail during the development of the Workgroup Report.

1.2. Modification Outline

In providing a brief overview of the Modification, JW requested that the Workgroup note that going forwards 0652 will align with (and be developed alongside) UNC Modification 0644 'Improvements to nomination and reconciliation through the introduction of new EUC bands and improvements in the CWV' (and indirectly DESC) meetings and timelines, before returning to the Distribution Workgroup at a later stage.

It was agreed that the technical analysis, should be completed within the auspices of 0644 (and 0652) with regular feedback into the Distribution Workgroup.

When asked, JW agreed to consider amending the Modification to include better clarification around data update and WAR band timings aspects etc.

PG focused attention, on the proposed timetable on page 2 of the Modification, noting that the forthcoming holiday season could potentially impact on end date.

Whilst reviewing the Solution (Section 5 on page 5), RH confirmed that there are no system read submission impacts envisaged at this time.

Concluding discussions, RH then pointed out that a Rough Order of Magnitude (ROM) request would need to be raised and submitted in due course.

New Action 0301: Joint Office (CS/BF) to ensure that a Rough Order of Magnitude (ROM) request for 0652 is raised once sufficient information is available.
