1. Introduction and Status Review

1.1. Approval of Minutes (24 May 2018)

The minutes from the previous meeting were approved.

2. Consideration of Amended Modification

AC provided an overview of the amended Modification highlighting the updates made, these included a change to the title, and a change to the data items table. AC clarified the data table will be included in the UK Link manual.

AC provided Suggested Legal Text and Commentary for the Workgroup to consider. He confirmed that the Suggested Legal Text for this modification will overwrite UNC 0434 Project Nexus – Retrospective Adjustment, Legal Text for a number of relevant aspects.

3. Development and Completion of Workgroup Report

The Workgroup considered the Workgroup Report.

The Workgroup considered the materiality of the modification and whether this could be managed as a self-governance modification. It was felt that the modification did not meet the

self-governance criteria, although this was difficult to justify against the Panel Guidance criteria.

The accuracy of data was considered and the data cleansing exercise that would be involved.

PO confirmed that a ROM has not been produced for this modification, however a high-level impact assessment has been undertaken under Request 0624R which he believed could be referred to in relation to the potential costs.

PO reported that the impact assessment suggested a 9-month lead time would be required for the data cleansing exercise. For this to be a candidate for a 2019 release, he pointed out that Ofgem would need to make a decision in September. This would allow 12 months for the system build and data cleansing.

The option of undertaking the system build changes with approval from the DSC Change Management Committee was discussed. PO confirmed the detailed design has not yet been discussed at DSC, however he suggested that this change could proceed on the understanding it would have to proceed at risk.

The Workgroup considered the implementation timescales and if there was a delay in implementing by 3 months, would this have any significant impact.

The Workgroup reviewed and concluded the report for submission to the July UNC Panel meeting.
