1.0 Introduction and Status Review

1.1 Approval of Minutes (28 June and 26 July 2018)

The minutes from the meetings held on 28 June and 26 July were approved.

2.0 Amended Modification

Bob Fletcher (BF), invited Shelley Rouse (SR) on behalf of Graham Wood to provide a brief update on the amended Modification.

SR confirmed that this is now a Self -Governance Modification which is being proposed to benefit industry by allowing the Performance Assurance Committee (PAC) to submit requests for new and amended reports to the UNCC for approval and thereby providing a quicker and more efficient process.

Steve Ladle (SL) asked if a parallel IGT Modification is needed as the Performance Assurance Report Register (PARR) and an IGT UNC impact is referenced. BF suggested that the cross-code impacts need to be considered for inclusion in the Workgroup Report.

3.0 Change Governance

Not discussed.

4.0 Legal Text

A brief discussion took place as to whether the Workgroup Report could be completed without the Legal Text. BF confirmed that the Workgroup Report could be completed with a statement to indicate that the Legal Text had not been reviewed because it was not available. He also confirmed that without Legal Text the Modification could not proceed to consultation.

It was noted that Legal Text had not been requested at the August Modification Panel meeting, as an amendment to the Modification was anticipated.

Discussion of this item was therefore deferred until the next meeting as the Legal Text was not available.

5.0 Development of Workgroup Report

Development of the Workgroup Report was also deferred until the September meeting.

6.0 Next Steps

BF confirmed that a one-month extension would be requested to enable a review of the Legal Text and potential impacts on IGTs to be considered and included in the Workgroup Report.
