1. Introduction and Status Review

Update: AW discussed the notification mechanisms and it was agreed this action could then be closed. **Closed**

Action 0103: Reference Transparency on the National Grid Website - National Grid NTS (AW) to provide feedback on the development and rollout of the collaborative web site facility at the 07 March 2019 Workgroup meeting.

Update: AW presented an update on the transparency on the National Grid Website and it was agreed this action could now be closed. **Closed**

Action 0104: Reference Potential Gas Deficit Warning Name Change - National Grid NTS (AW) to provide assurance that any proposed name change satisfies EU regulatory requirements.

Update: AW explained how the Gas Deficit Warning name change would not impact EU regulatory requirements, and it was agreed this action could then be closed. **Closed**

Action 0105: Reference (draft) Request Workgroup Report development - National Grid NTS (AW) to invite Glenn Bryn-Jacobsen of National Grid to provide an update at the 07 March 2019 Workgroup meeting.

Update: This action was requested to be carried forward. Carried forward

Action 0106: Reference (draft) Request Workgroup Report development - National Grid NTS (AW) to discuss the additional areas requested by the Workgroup with Terminal Operators and provide a view as to whether or not, these would have made a difference to the 01 March 2018 emergency event approach.

Update: AB noted that there was a misunderstanding that capacity would be available at LNG sites but this was dependant on other factors such as temperature of the liquified gas which would impact how the site operated. This action was requested to be carried forward. **Carried forward**

3. Review of Amended Request Proposal

Angharad Williams (AW) presented the National Grid NTS proposal for a more dynamic and transparent calculation of Non-Storage Supply assumption. She explained that the UKCS and Norway were monthly calculations, and that the proposed interconnectors and LNG calculations would be updated on a daily basis according to a pre-defined rule.

A general discussion took place and the consensus was this would be a positive change and Terry Burke (TB) said his preference was for the interconnectors to use the D-1 nominations, however he wanted to know what the cut off time would be. Graham Jack (GJ) wanted to know why the within day nominations could not be used. Phil Hobbins (PH) explained that this was because the NSS feeds Margins Notice, was a day ahead process. PH also said that potentially National Grid NTS had proposed an LNG methodology, which was similar to storage, given the similarities of operation.

Adam Bates (AB) felt that this proposal was not that simple, regarding the LNG in the tanks as it would depend on when the next delivery was due and there would be a possible gas warming in the tanks should offtake rates be exceeded and that this would need to be taken into consideration. He agreed to investigate this area in more depth.

A lengthy and protracted discussion took place regarding the Margins Notice Trigger and Bill Reed (BR) requested that this should be published on a prominent part of the National Grid NTS website, AW confirmed that this would be considered as part of the project to improve transparency on the National Grid website (as per action 0103).

AW said that for the next meeting she will present more in-depth analysis in order to include this information within the Modification and enable Legal Text to be produced, for submission to the May Panel.
