M Montgomery (MM) provided a status update on the Gemini Sustain Plus program.

The project remains on track for September 2024 implementation. The Programme has converted the legacy code into modern code and is now performing development and testing of the new screen designs and features:

- The detailed design change pack has been issued, reviewed and approved at the February DSC Change Management Committee.
- The Focus Group are well attended.
- Work continues with the Platform team for the interface build.
- End-to-End testing and Systems integration testing are due to commence imminently.

Next Steps:

- Continue development and testing of the Gemini process of functional components, new screens and batch jobs.
- Engaging with industry to prepare it for the changes ahead and the Market Trials period.
- Training content being developed for release in Q2 2024.
