1 Summary

What

Under UNC Modification 0565A Central Data Service Provider: General framework and obligations, UNC Transportation Principal Document (TPD) Section U was deleted; some rules were moved to General Terms, Section D and other rules were included in a revised UK Link Manual which now exists as a CDSP Service Document, being one of the component documents comprising the new Data Services Contract. During development of Modification 0565A there was insufficient time to develop a comprehensively revised UK Link Manual. Therefore the UK Link Manual Framework Document was developed in recognition that a revised UK Link Manual would be prepared in anticipation of Project Nexus implementation (01 June 2017). This Modification seeks to amend the DSC by creating a new and revised UK Link Manual document which will replace the existing manual.

Why

This Modification is proposed in order to create a new and revised UK Link Manual which is up to date and fully reflects the requirements of Project Nexus and the new role of Xoserve as the CDSP.

How

The DSC UK Link Manual has been developed based upon the Ofgem Funding Governance and Ownership (FGO) review of Xoserve and Modification 0565A principles. The majority of the changes are structural in nature; the detail of the existing UK Link Manual e.g. the file formats and hierarchy are not amended by this modification.

2 Governance

Justification for Self-Governance

The Modification Panel determined the modification is unlikely to have a material effect on UNC governance or modification procedures because it brings into effect an arrangement already established by UNC Modification 0565A. It creates the UK Link Manual under the DSC and as such is a non-material change to the services under the UNC.

Modification 0613S will therefore follow self-governance procedures.

Requested Next Steps

This modification should:

- be considered a non-material change and subject to self-governance;
- issued to consultation.

Workgroup participants agreed that this modification is sufficiently developed to be issued to consultation.

The Workgroup agreed with the Modification Panel's determination on Self-Governance as this modification is unlikely to have a material effect on UNC governance, competition or contractual arrangements because it brings into effect the arrangements already established by UNC Modification 0565A. It creates the UK Link Manual under the DSC and as such is a non-material change to the services under the UNC.

3 Why Change?

This Modification is proposed in order to create a new and revised UK Link Manual which is up to date and fully reflects the requirements of Project Nexus and the new role of Xoserve as the CDSP.

The UK Link Manual Framework Document, see paragraph 1.5.4 in the following link [http://www.gasgovernance.co.uk/UK Link Manual Framework Document.pdf](http://www.gasgovernance.co.uk/UK%20Link%20Manual%20Framework%20Document.pdf) explains that prior to the Project Nexus Implementation Date (01 June 2017), a revision of the UK Link Manual will be required in the context of the Nexus Modifications and it is intended that, as part of such revision, the different component parts of the UK Link Manual will be consolidated into a new and revised UK Link Manual.

This is a significant DSC change and while in principle, the DSC Change procedures could be followed, the UNC Modification procedures are being followed to ensure full transparency and visibility of the change. However, it's noted that there would be no material UNC impacts due to the implementation of this modification.

Modification of the DSC is necessary to replace the current UK Link Manual with a new and revised UK Link Manual document.

6 Impacts & Other Considerations

Does this modification impact a Significant Code Review (SCR) or other significant industry change projects, if so, how?

Neither the SCR nor any significant industry change project is impacted.

No cross-code impacts have been identified. No direct impacts were identified through the DSC Change Management process.

No central systems impacts have been identified as the UK Link Manual documents existing processes established by Project Nexus.

Workgroup Impact Assessment

The Workgroup notes that the new UK Link Manual proposed by this modification would satisfy the requirements to establish a new UK Link Manual under the DSC arrangements established by Modification 0565A.

It should be noted that the Workgroup has assessed the documents which directly impact the UNC and/or DSC terms and conditions and that the DSC Change Procedures were used to review documents that were systems related. The DSC Change Management Committee supports the implementation of the systems related documents it was requested to consider during the assessment of this modification.

UK Link Manual and its associated, documents and legal text are published alongside this Workgroup Report and a summary table is provided below to provide guidance.

UK Link Manual - Table of legally binding provisions

In labelling some of the Component Documents as binding (and others as not) the aim is to give much greater clarity to the rule in GT D5.2.3, which states that it is an obligation to comply with those provisions in the UKLM which are 'expressly identified in the UK Link Manual' as binding. The wording at GT D5.2.3 was moved from UNC TPD Section U (it dates back to 1996), and the intention in the new UKLM is not to make parts of the UKLM binding where this has not previously been the case. It should also be noted that GT D5.2.3 contains the acknowledgement that where any provision of the UKLM is not followed (whether or not a binding provision) that it may impact on the ability of a UK Link User to make UK Link Communications.

Separately, it should be noted the DSC creates bilateral contractual relations between the CDSP and Customers only, and the intention is not to create relations between individual Customers. Accordingly, the DSC does not concern issues connected with any potential consequences of one individual Customer's non-compliance with the DSC (including the UKLM) on another individual Customer.

The Workgroup were content to recommend that the new UK Link Manual was not a material change to UNC and that this modification and the documents which make up the UK Link Manual should be issued to consultation.

Rough Order of Magnitude (ROM) Assessment

A Cost estimate is not required from the CDSP. This modification creates a new and revised UK Link Manual which is up to date and fully reflects the requirements of Project Nexus and the new role of Xoserve as the CDSP. The administration costs of undertaking this exercise will have already been accounted for under Project Nexus and Modification 0565A.

This Modification seeks to ensure that the terms identified within Section 1.5.4 of the CDSP Service Document, being the 'transitional' UK Link Manual Framework Document can be met. Discussion

The Panel Chair summarised that Modification 0613S seeks to introduce the updated UK Link Manual into the Data Services Contract.

Members considered the representations made noting that implementation was unanimously supported in the 9 representations received.

Members agreed with respondents and the Proposer that this modification would ensure that the terms identified within Section 1.5.4 of the CDSP Service Document, being the 'transitional' UK Link Manual Framework Document can be met. In addition, this modification provides that an 'enduring' UK-Link Manual can be implemented.

Consideration of the Relevant Objectives

Members considered relevant objective f) Promotion of efficiency in the implementation and administration of the Code, agreeing that implementation would have a positive impact because this modification will ensure that the terms identified within Section 1.5.4 of the CDSP Service Document, being the 'transitional' UK Link Manual Framework Document can be met. In addition, this Modification provides that an 'enduring' UK-Link Manual can be implemented thereby removing the transitional document.
