

APPLICATION FOR CONSENT TO MODIFY THE NETWORK CODE OF WALES & WEST UTILITIES

“Revision of ‘Transporter’ from ‘Blackwater 2’ to ‘Wales & West Utilities’”

Transporter Proposal

The Network Code specific to Wales & West Utilities Ltd, formerly named Blackwater 2 Limited, pursuant to paragraph 3 of special standard condition A11 of the gas transporters licence, was introduced in May 2005. In June 2005 ‘Blackwater 2 Limited’ became ‘Wales & West Utilities Limited’. The Wales & West Limited Network Code remained unchanged and still contains references to ‘Blackwater 2 Limited’ and the registered address of National Grid Transco. It is understood that amendments, such as company name revisions, can be achieved through a ‘Consent to Modify’ as it is not believed that such a revision is a material change to the intent of a Network Code, and therefore does not require a change through the Modification process.

Please find attached Consent to Modify request from ‘Wales & West Utilities Limited’, which amends the Transporter name from ‘Blackwater 2 Limited’ to ‘Wales & West Utilities Limited’ and the associated registered address.

Nature of Modification

The Network Code relevant to Wales and West Utilities Limited contains the incorrect Transporter name, ‘Blackwater 2 Limited’, and the incorrect Registered Address.

1. Network Code

This document is the network code of ~~Blackwater 2Wales & West Utilities~~ Limited prepared pursuant to Standard Special Condition A11(3) of the Transporter's Licence.

2. Interpretation

In this document:

"Transporter" means ~~Blackwater 2Wales & West Utilities~~ Limited registered in England with number 5046791 whose registered office is at ~~1-3 Strand, London WC2N 5EH~~ Wales & West House, Spooner Close, Coedkernew, Newport, NP10 8FZ a corporation organised and existing under the laws of England.

"Transporter's Licence" means the gas transporter's licence granted or treated as granted to the Transporter under Section 7(2) of the Gas Act 1986, as from time to time in force;

"Network Code" means this document as from time to time modified in accordance with the network code modification procedures set out in the Uniform Network Code or the Transporter's Licence;
