OVERVIEW

The purpose of this document is to keep stakeholders informed of recent activity and progress in delivery the AUGE service.

Key points for October 2021:

- ▶ Data analysis is complete for the new contributors (Isolated Sites and Meter Bypass). UIG from sites with Meter Bypass will not feature in our modelled output for this year's AUG Statement. Three key inputs to this calculation are: 1. Bypass status information; 2. Duration of bypass operation; 3. The ability to link a specific consumption adjustment to a bypass operation. We currently have insufficient confidence in the available data for all three of these inputs to make a robust judgement on related UIG. Instead, we will reassess the inclusion of this contributor next year following output from the ongoing industry review of data quality in this area.
- ▶ Data analysis for the refinement contributors is almost complete.
- ▶ Our updated overall Consumption Forecast is nearing completion.
- ▶ We have done some analysis on the 01NI theft dataset which will be released to Shippers in November pending discussion with Xoserve on presentation of the data.
