An amended Change Pack will be issued in June, for information, to clarify that Shippers have the option to either all shippers receiving the Biomethane site data or only incumbent Shippers assigned to the impacted supply meter points. 	<p>Scope options will be presented in Julys meeting for a proposed February 23 Release and June 23 Release.</p> <p style="text-align: center;"><u>Projects Updates</u></p> <ul style="list-style-type: none"> • Delivery Release Options XRN5091 and XRN5186 – For Approval – Customers agreed to defer this decision until July when there is a cost for the partial workaround for XRN5186 and a decision on the scope for February and June 23 • November 2021 Major Release – Closedown activities are currently progressing, CCR to be included in July's ChMC meeting
