DDP-396	XRN4876 - As PAFA I want to see the number of AQ corrections that are rejected per reason code so I can monitor how many AQ corrections are being rejected by UKLink so that I understand the reasons why Aqs are being rejected

Next Steps

Update

- Following 4 months of PAFA focused delivery we are due to deliver the scope of XRN4876 as planned. XRN5321 will be used to draw down on next years budget. Prior to commencing any work on XRN5321, we will need to raise statements of work and get CHMC approval to draw down on the budget. Once approval is obtained we can begin mobilisation for delivery activities.

Next Steps

- Seek approval from CHMC to draw down funding from XRN5321
- Mobilise for delivery (onboard resource etc.)
- Initiate XRN5321 delivery
- Submit close down documents for XRN4876 to CHMC

Risks

- Resourcing only available via contractors (cost implications)
- Shipper Constituency does not prioritise PAC deliverables creating misalignment between visibility of insight by PAC and Shippers
