Amended paragraph 1.1.1	Add reference to rules also covering IGT LDZ System Entry Points.

Amended paragraph 1.1.1	Ad reference to rules also covering reverse compression.
New paragraph 3.5	New heading.
New paragraph 3.5.1	Explanation of what is meant be reverse compression.
New paragraph 3.5.2	Requirement that no gas can flow into the LDZ in the absence of an LDZ System Network Entry Agreement being in place between the IGT and the DN Operator and which addresses (in a manner satisfactory to the DN

	Operator) the monitoring of reverse compression gas flows and the operation of the reverse compression facilities where the DN Operator is carrying out maintenance on its system.
New paragraph 3.5.3	Requirement that gas which is subject to reverse compression cannot be offtaken at premises connected to the IGT System.
New paragraph 3.5.4	Disapplication of rules in TPD Section I in relation to the LDZ System Network Entry Agreement regarding availability of relevant Network Entry Provisions, amendments to Network Entry Provisions, the requirement of measurement rules and certain System Capacity related rules regarding LDZ System Entry Points.
New paragraph 3.5.5	Rules to recognise that gas flowing back into the LDZ as a result of reverse compression is to be treated (for Gas Act purposes) as being introduced into the LDZ by Shippers (analogous with the rules at NTS/LDZ Offtakes – see TPD J1.3).
New paragraph 3.5.6	Default rules to address any unexpected issue which might arise regarding title to gas flowing from the IGT to the LDZ (again analogous with TPD J1.3).
New paragraph 3.5.7	As above.
New paragraph 3.5.8	Requirement DN Operator share information regarding the expected use of its System with a IGT considering installation of reverse compression facilities.
New paragraph 3.5.9	To confirm DN Operator will not have any liability to the IGT for information shared under paragraph 3.5.8.
