1. Introduction and Status Review

1.4. Approval of Minutes (19 July 2022)

1.6. Review of Outstanding Actions

Mark Perry (MP) provided a brief presentation confirming the DESC Members and current Alternates and any missing Alternate to be advised to Joint Office to update. A proposed Workplan was included. MP asked Committee members to consider if they have any experts they would like involved in the Climate Change Methodology Technical Workgroup. **Closed.**

2. 2022/23 NDM Algorithms Update

Penny Griffiths (PG) provided an overview of the NDM Algorithms Update Detail could be found here https://www.gasgovernance.co.uk/DESC/051022.

The presentation provided confirmation of activities since July meeting, when DESC provided approval of the final Gas Demand Profiles for Gas Year 2022/23 and enabled a discussion on the impact of the cost of living crisis on NDM accuracy.

PG provided a brief on the background of possible changes to the Demand Estimation profiles which DESC could make to support the industry in relation to the ongoing over allocation of the NDM Algorithm. PG explained that because of the rise in the wholesale gas price and warm weather, there has been significant negative Unidentified Gas (UiG) during Gas Year 2021/22. It is likely the forecast of the NDM consumption for 2022/23 will continue to be over-allocated as end users are not using as much gas through enforced conservation. As the ALPs and DAFs will not be able to correct and AQs will not be able to reflect the base level demand, DESC could consider intervening, as they did in 2018/19 Gas year (for opposite reasons).

The proposal discussed is to amend the ALPs and DAFs by applying reduction factors, which would have the effect of counteracting the AQs being too high

PG asked DESC to provide input/views on the proposal as changes to the ALPs and DAFs need DESC approval.

The Committee discussed the ongoing issue and the proposal in length regarding the D-5 and D-1 forecast; the prices vs demand impact; the reasoning of adjusting domestic customers; the advantages and if this fixes the root cause.

YRH asked The Committee to vote for the approval of the Changes as laid out in the 2022/23 NDM Algorithms. The Committee votes are as follows:

The Committee all agreed the over-allocation is an issue and needed to be investigated. However, the proposed solution would not fix the root cause i.e. AQs not being as reflective of the current base level demand. It was agreed this topic will be reviewed in December Meeting and on regular basis

3. Seasonal Normal Review 2025

Michael Maguire (MM) provided an overview of the review cycle of the Composite Weather Variable (CWV) and Seasonal Normal equivalent referred to as the SNCWV.

The Committee were asked to consider what may be needed, particularly with regards to the using of a "Climate Change Methodology (CCM)," for the next Seasonal Normal Review due to take effect in 2025.

MM presented the Weather Analysis and explained the change of Methodology is required due to the continuing trend of warmer Gas years being experienced, particularly since 2013/14. MM asked DESC to provide views and comments on the proposal; and if this proposed change is approved, Xoserve will draft the Change Proposal for Change Management Committee (ChMC) approval, and consultation from Technical Group to feed into the process. Xoserve plan to start the procurement process in Q1/2 2023 by inviting potential vendors.

The Committee agreed that the review should consider the costs, timelines, and approach.

YRH asked The Committee to vote for the approval to procure a Climate Change Methodology to support the calculations for the next Seasonal Normal Review due in 2025.

The Committee unanimously approved the CCM to support the 2025 Seasonal Normal Review as follow:

With the Modification 0754 Workgroup update, Demand Estimation Team will continue the investigation and analysis proposed in Modification 0754. 4.2. End User Category (EUC) Review (Action 0704)

CDSP (MP) was asked to provide DESC members with a list of data sets which would assist reviewing EUC definitions.

Penny Griffiths (PG) provided an overview of the existing EUC definitions (Band 1 – Band 9) and proposal to investigate in a better approach to manage various Band particularly the Large EUCs.

The key issue is that there are insufficient sample meters for forecasting purpose across the Bands. Proposals are to combine the Bands and if still insufficient data, combine the neighbour LDZs

YRH queried asked if there are risks or impacts if insufficient data received. PG confirmed that it would affect the accuracy of the forecast.
