2. DSC Change Budget Update & Horizon Planning

2.1. Change Budget Update

James Rigby (JR) provided a brief update of the DSC Change Budget for 2021/22, advising that there had been no new updates with the exception, of the PAC funding adjustment in line with the vote in June Committee or changes following the approval at the June meeting.

2.2. Change Pipeline

Rachel Taggart (RT) presented the Change Development and Delivery Pipeline, noting there was little difference in the Change Pipeline besides the current Change Proposals (CP) moving through the change lifecycle as previously agreed by the Committee at the June meeting.

3. Capture

3.1. New Change Proposals – Initial Review

3.1.1 XRN5377 - Addition of 'Class' field to supply point data reports

Steve Pownall (SP) provided a brief overview of this CP noting it would provide the ability to identify Class 1 and 2 supply points which do not have Formula Year AQ and SOQ, which would help with the analysis month on month movements.

DNO Members were asked to approve the change to progress into the Capture phase.

3.1.2 XRN5379 Class 1 Read Service Procurement Exercise (Modification 0710)

Ellie Rogers (ER) provided a brief overview of this CP noting that it was very similar to XRN5218 that was originally a CP in relation to Modification 0710S - CDSP provision of Class 1 read service. ER noted that XRN5218 would be withdrawn and replaced by XRN5379.

ER explained this CP will allow time and effort from the necessary areas of the business to effectively follow the procurement process to appoint a Service Provider under a new contract for the Class 1 read service. The benefit is the appointment of a Service Provider on behalf of Shippers, to provide the Class 1 read service from 01 April 2023 when the existing contracts end.

Oorlagh Chapman (OC) enquired if there was a risk that this could exceed beyond this date, due to more issues. ER / Paul Orsler (PO) stated that it was a completely new contract and so the overall transparent procurement process would be adhered to, although it would not have the added complexity associated with contract novation. OC asked if the previous issues were going to be disclosed and ER said that was a timing issue previously, so the issues would not be shared.

Clare Manning (CM) enquired why a CP was being used for the procurement process and not planned into the Business Plan process (BP22). PO explained it was in relation to the requirements as detailed within Modification 0710S concerning resources and the competitive tender process. Claire Louise Roberts (CLR) asked if these resource costs, would be deducted from the Business Plan (BP) and PO said these were extra and would be listed as a DSC Charge to release some funding for next year. B Fletcher (BF), asked if the procurement was being established as the first event due to the Modification implementation and future service procurement events would be delivered in the Business Plan? PO confirmed this was a correct assumption.

3.1.3 XRN5380 Introduction of a Micro Business identifier in Central Systems

Ellie Rogers (ER) provided a brief overview of this CP noting that this change would create an identifier to be able to easily identify where a site is a Micro Business and will allow the ability for all stakeholders to be able to provide services to those customers efficiently and consistently across the market.

ER noted that Ofgem are proposing that the Micro Business Cooling Off Period is effective from the 01 January 2022 and it is being requested within the Modification 0773 - Introduction of a Micro Business identifier in Central Systems that the implementation of this solution is ahead of this.

CLR asked if this was going to be applicable for electricity as well. PO explained that this already existed in electricity and so there was presently a gap within gas as there was no additional identifier for Micro Business. He added due to the Supplier Licence change in January 2022 there was now a requirement within gas too. Clare Manning (CM) asked if it would be retrospective or fixed forward. PO said this was presently being investigated at the present time and discussions will be worked on through development of the Modification.

3.1.4 XRN5381 Changes to SDT v18

RT provided a brief overview of this CP and explained this was for information only to advise that the Service Description Table V18 has been amended to align the service lines to the new Process Journeys that came into effect on 01 April 2021. They now reflect the changes to the Service Areas as detailed within the charge base Appointment Table as per CDSP Service Document Budget and Charging Methodology version 5.

OC questioned whether this had any direct impacts on charges in relation to last years' budget and said that it could make it difficult to track the budget and the overall spend with previous years if the service lines keep changing or being realigned. She felt that a consultation may be required.

Emma Smith (ES) and Jayne McGlone (JMG) explained that the amendments to the service lines were voted on last year and the costs were going through as approved as of 01 April 2021.

JMG also noted that this is a housekeeping change as the realignment and consolidation of service lines has previously been approved and were live since 01 April 2021, this CP brings the table into line with the process. OC said that a detailed explanation would still be beneficial for her to share internally. Sally Hardman (SHa) confirmed that this change was approved last year.

JMG confirmed that this CP would be submitted for approval by the DSC Contract Management Committee at the 21 July 2021.

3.1.5 XRN5382 FWACV: PRCMS validation/processing – analysis

Steve Pownall (SP) provided a brief overview of this CP noting it was regarding the provision of a Daily LDZ CV (FWACV) Service, where Xoserve will provide this service to DNOs from Q1 2022 taking over the service currently provided by National Grid.

3.1.8 XRN5183 Access to Daily Biomethane Injections

Kathryn Adeseye (KA) provided a brief overview of this CP noting that this change had been to the DSC Change Management Committee previously in relation to Option 1: Was to publish the current BEIS Biomethane Injection report on a secure part of Xoserve.com; and Option 2: Was to create a bespoke Biomethane Injection report where the data is aggregated at a specific geographical level, LDZ being one option among many. The report could be published on Xoserve.com open to all OR published in a secure area of Xoserve.com.

At the November 2020, ChMC, Option 1 was approved following the solution option change pack, however this was then discussed with BEIS and the CoMC regarding permissions being covered under the DSC. Both entities expressed concern that this could potentially give a commercial/financial advantage to some industry parties over others. It was agreed that Option 1 should be withdrawn.

KA explained Xoserve wanted the DSC Change Management Committee to re-approve the HLSO for XRN 5183 with Option 2 as the agreed solution to move into delivery. (As a new report will need to be created).

XRN4931 Submission of a Space in Mandatory Data on Multiple SPA Files

Simon Harris (SH) provided a brief overview of this CP noting the change has been raised to handle the files going back out from SAP into AMT with rejection details when a space 'is received in the mandatory field. SH noted a that this had been discussed previously. He explained Option 1. Replace the spaces received in the mandatory field of inbound files with single special character in SAP PO and SAP ISU will identify the special character and mandatory field missing rejection will be sent in outbound files. and Option 2. Replace the spaces received in the mandatory field of inbound files with same number of special character(s) in SAP PO then SAP ISU will identify the special character and a mandatory field missing rejection will be sent in outbound files.

He said that Xoserve were proposing to withdraw the request and sought agreement from the DSC Change Management Committee.

OC said she was confused about the vote and that the two options did not seem clear enough and that clarity was required. PO said that Xoserve had not wanted to influence the vote and that they would look at the format and content of the slides for future similar votes. BF said that as the normal table was not available it was not as clear as with other CPs what was being asked.

Members unanimously agreed to defer the CP and that it was to be included in the formal Change Pack for further discussion at the August meeting.

3.1.9 Retrospective Data Updates Options Paper for Consultation

Paul Orsler (PO) provided a brief overview for information of this CP noting from the reps already received, that Option B was the most preferred choice. as it was deemed to be the most cost-efficient solution and would deliver industry benefits much quicker than option A, without impacting ongoing CSS delivery.

He noted the consultation was still open and that the responses would be presented to the DSC Contract Management Committee at the July meeting, in relation to delivery against Modification 0651 - Changes to the Retrospective Data Update provisions.

OC asked if further consideration had been given to the suggestion by SSE regarding a workshop to discuss the options in detail. PO said that as this would have to be resourced by dedicated experts and he was unsure how much detail was needed. He said he would raise this matter at the DSC Contract Management Committee on 21 July 2021.

3.1.10 XRN5365 Impact assessment on aligning Major Releases to the REC Release Schedule

Simon Harris (SH) provided a verbal update of this CP noting that there were regular meetings with REC and that the DSC and system changes were fed into the REC Code changes and that any comments and feedback were part of the impact assessment. He added that REC was expected to move to a weekday; Thursday/Friday release schedule which CDSP advised would be achievable dependant on the change with the need to maybe do some weekend development on a change-by-change basis with a switch to a weekday implementation. He explained it was the intention to have an additional functional Major Release in February, currently the releases are June and November. SH noted that this would increase the existing release congestion. PO added that this topic had been discussed with Xserve's' Shipper customers and they were not keen on this proposal as they would have to make changes to their systems interfaces. SH said he would supply a structured and detailed update at the August meeting.
