#### 2. Matters for Committee Attention

## 2.1 Annual Review 2021 Update

A Jackson (AJ) provided an brief overview of the most recent changes undertaken within the document in-line with PAC Member's feedback at the 14 September 2021 PAC meeting.

During an onscreen line-by-line review of the 'Performance Assurance Framework – Annual Review and Feedback Request 2021' document, the following key points were noted (by exception):

- The basic assumption being made when presenting these latest changes is that the changes provided ahead of the 14/09/21 PAC meeting were accepted by the PAC Members who attended the meeting;
  - The latest layer of changes reflect the additional feedback provided at the meeting;
- As far as the 'Executive Summary' related changes are concerned;
  - Table 1.2: 'Average read performance (%) of Parties under active monitoring' on page 6 has been amended to include additional refinements to the data provided to reflect the progress made by Shippers that have been engaged with the PAFA:
  - The data in the table better reflects the progress made over the last 12 months;
- The statement that commences at the bottom of page 6 and rolls over onto the top of page 7 has been tweaked to include updated numbers, plus an additional narrative for clarification of the PARR reporting elements;
- The opening statement at the top of page 8 was moved from it's original position earlier in the Executive Summary;
- Table 1.2: 'The percentage (%) of Parties meeting UNC requirements for each meter reading class' has had the green / red highlighting removed;
  - More work (by PAC) needs to be undertaken in this area during the course of the year going forward;
  - The statistics reflect the percentage of parties that are NOT meeting their targets, which is subtly different to reaching UNC Code targets;
  - Observation is that targets need to be achievable;
    - Financial cost of achieving targets needs to be carefully managed;
    - These statistics provide a sound starting point;

- PAC are currently working outside of Code (until UNC Modification 0674 is potentially approved for implementation);
- More tangible PAC measures are required before PAC has any formal weight and leverage;
- The evidence provided appears to support the aims of UNC Modification 0674;
- It was acknowledged that under the current market conditions whereby several smaller Suppliers are going under, parties may have their focuses elsewhere;
  - Counterfactually, Shippers / Suppliers who are less vulnerable might be able to focus on obtaining and submitting reads and thereby generating greater income;
- The closing statement on page 9 has been moved to now sit under Section 7. 'UNC Modification proposals Industry change', on page 28, and
- The various graphs contained within Section 4. 'Performance Improvements (to date)' now contain the UNC Target point.

**New Action 0901 (extra):** Reference the Performance Assurance Framework – Annual Review and Feedback Request 2021 – Joint Office (RH) to look to ensure that the UNC Modification 0674 Workgroup are aware of the feedback request document (and impending 6 week consultation) and undertake due consideration during forthcoming Workgroup discussions.

Moving on to consider approval of the document, when asked there were NO adverse comments forthcoming from PAC Members in attendance – **unanimous approval**.

Considering the proposed six (6) week consultation period, when asked there were NO adverse comments forthcoming from PAC Members in attendance – **unanimous approval**.

Considering the provision of post consultation feedback at the 16 November 2021 PAC Meeting, when asked there were NO adverse comments forthcoming from PAC Members in attendance – **unanimous approval**.

When asked, RH confirmed that if the PAFA prepares an industry awareness email for the proposed consultation, the Joint Office would assist in circulating to the industry and raising awareness via UNC Panel and UNC Workgroup meetings whilst the PAFA would 'cover off' the IGT side and Huddle platform part of the equation.

It was acknowledged that these are difficult times in the UK Energy Market which may result in a less than favourable level of responses.

#### 3. Any Other Business

## 3.1 GB Supplier / Shipper Failures

The PAC Members in attendance contemplated the potential impact of the current Energy Market (wholesale price related) difficulties which is resulting in several of the smaller Shipper / Supplier entities leaving the market (going bust), noting that there are some that have already ceased trading, or are close to ceasing trading that could already be on PAC's performance issues radar – closer monitoring of the situation over the coming weeks will be of paramount importance going forward.

It was noted that as a consequence of the failure of parties, there could be a direct impact on the October PAC Dashboard reports, especially as there could be some settlement related impacts involved.

Whilst it was debated as to whether there would / could be an advantage in issuing a 'Key Messages' statement to the industry, it was felt on the whole that this might not be the right 'balance' to the approach at this point in time and that it might be prudent to observe the market from a distance, especially baring in mind that PAC does not currently have sufficient evidence on which to base any meaningful decisions.

Moving on, PAC Members in attendance briefly considered the issue of whether some parties (namely, larger I&C ones) might be 'self-disconnecting' their supplies (as implied in recent Press communications), in order to avoid incurring additional debt when energy prices are high. However, it was also noted that parties 'self-disconnect' for maintenance purposes, although there are potential concerns where NDM sites are involved.
