1. Introduction and Status Review

1.1. Approval of Minutes (21 January 2020)

The minutes from the previous meeting were approved.

1.2. Pre-Modification Discussions

Rhys Keally (RK) advised the workgroup that he was considering raising a modification to address three areas, voting arrangements at the UNCC, addressing stability between draft and modified/final AUG tables and establishing a route of appeal. He wished to propose a change to the voting mechanism and the consultation process involved with the AUGE process and he also wanted to consider an appeal process. RK welcomed views from the Workgroup to assist with articulating the Modifications. RK advised workgroup that he is hoping to raise this modification for discussion at the March Modification panel meeting.

Tracey Saunders (TS) suggested that RK should draft a Modification or Request to explain what he was trying to achieve. TS explained the options of raising a Modification where the solution had been identified and the option of raising a Request if the solution is not known.

The Workgroup discussed the current process whereby the UNCC can reject the AUGE table by consensus.

Mark Bellman (MB) wished to point out that the AUGE is appointed by the industry as an expert, and that there is a defined process for appealing a change to the AUGE table. MB explained the process currently used to avoid a zero sum game and universal approval is required to reject the AUGE table.

Louise Hellyer (LH) provided some feedback on what elements RK may wish to consider when drafting the Modification.

Tony Perchard (TP) suggested a hard cut-off for the first draft AUGE table which may aid the process. The hard cut-off could prevent a change in the methodology beyond that date.

Kirsty Dudley (KD) asked for further clarity for the AUGE table sign-off, as there are certain validation rules. KD wished to understand if this was a generic change for all elements of the process or if this was a change only for certain aspects, and which ones would be by majority or unanimous. KD also wished to understand if this change would be for everything that is approved by UNCC.

Fiona Cottam (FC) clarified that a unanimous agreement is required to overturn the AUGE table.

It was agreed that RK would need to articulate the changes he is looking to make within a proposed Modification or Request, to aid a pre-modification discussion at next month's Workgroup meeting.

FC referred RK to TPD Section E.9.4.3 (h) which outlines the voting process for AUGE.
